2. Any further information may be obtained by inspecting at the project site at Minawar Gilgit at their own expense and also from the Office of the Director Engg-II at First Floor Shaheed-e-Millat Secretariat, Jinnah Avenue Islamabad.

Bids must be submitted in two duly sealed envelope separately with mark FINANCIAL PROPOSAL and TECHNICAL PROPOSAL with single outer envelope on or before **11:00 AM** on **01-07-2022** in the office of Director (Engg)-II PHAF in original duly signed and stamped & a scanned copy must be uploaded at PHAF official website designated location/link and only technical bids will be opened at **12:00 PM** the same day by the bid opening committee in the committee room of PHAF in the presence of bidder's representatives who choose to attend.
4. Incomplete and conditional bids shall not be considered.
5. No tender through Fax, Telephone and Telex would be entertained.
6. In case of difference between the bid submitted in the office of Director (Engg)-II (In hard) and the one uploaded (scanned copy) that is in case of any ambiguity/discrepancy in hard and soft form the bid shall be rejected and non-responsive.
7. No Bidding Document shall be available for downloading on the date fixed for opening of bids.
8. In case of any unforeseen reasons public holiday unrest or force majeure on the bid submission/ opening date the Bid shall be opened on the next working day at the same place and time.
9. All the federal taxes will be deducted from bills of the contractor as prescribed rates as per government policy issued from time to time.
10. If the successful bidder repudiate the contract his entire security deposit shall be forfeited in the favor of PHA-F further he shall be blacklisted.
11. PHA Foundation reserves the right to accept or reject any or all bids or proposals at any time prior to the acceptance of a bid in accordance with 33 PPRA Rules 2004.
