**ELIGIBILITY**

2. This Invitation for Bid is open to all Bidders meeting the following requirements:
  - a. Pakistan Engineering Council Registration renewed for year 2021-22 with at least **Category C-6** having Specialization Code of **CE-10 & EE-05**.
  - b. The bidder/JV must have demonstrated at least five year experience in the field of construction as per registration categories of PEC.
  - c. A Bidder/JV may be a natural person, private entity, or government-owned enterprise or any combination who is active tax payer.
  - d. The bidder/JV shall have furnished income tax returns for last three years duly verified by FBR.
  - e. PEC registered contractor must demonstrate at least five experience in construction industry.
  - f. Bidder/JV must demonstrate at least two (02) No. contracts that have been successfully completed within the last five (05) years similar to this work. However, value of each contract agreement/Work Order should not be less than **Rs. 4.00 Million** for the purpose, the bidder/JV shall provide relevant Work Order/Contract agreement & Completion certificates etc. Bidder/JV must demonstrate satisfactory performance of previous completed works.
  - g. The bidder/JV shall demonstrate at least the following financial criteria for last three (03) years duly certified from audited financial statements:

Manager (Development) IESCO, Islamabad. Bid security shall be valid for 28 days beyond bid validity and bid shall be valid for 60 days.
