

Pakistan Post Invites sealed Tenders in the form of TECHNICAL PROPOSAL and FINANCIAL PROPOSAL from reputed Companies / Firms registered with Income Tax / Sales Tax Department and active on ATL of FBR website, for out sourcing of space on the back side of ordinary Inland Postal Envelopes of Pakistan Post. The Companies/Firms will be authorized to provide this space to different departments / Organizations / Institutions for advertisement of their products / services.

2. The bidders will submit an affidavit stating that his firm has not been blacklisted by any Government / autonomous body and no legal action is under way against his firm.
3. Tender documents containing relevant information term & conditions can be collected from the office of the Assistant Director (Philately) Room No.77, Directorate General, Pakistan Post Office, Sector G-8/4, Islamabad during working hours by the 18-07-2022 on production of receipt of Rs. 5000/- deposited in cash (non-refundable) in any post office under the Head "Unclassified Receipt"
4. Sealed tenders are invited in accordance with the provision of Rule.36(b) of PPRA-2004 on single stage two envelopes. Each envelope contain separately "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL", which must be reached to the % undersigned by 19-07-2022 at 11:00 hours. The envelope containing Technical Proposal shall be opened on the same date at 11:30 hours in the presence of the bidders or their representatives who wish to be present. Bids received after the prescribed time and clock shall not be considered.
5. Bidders will be technically qualified on the basis of information provided with the bids, as per the criteria prescribed in the bidding documents. The unopened envelopes of "FINANCIAL PROPOSAL" including earned money / Bid Security of those bidders who fail to technically qualify shall be returned to them.
6. Pakistan Post reserve the right to reject any or all tender at any time stage as per PPRA Rules. Tender document will not be sold on the date of opening of the bids.
