#### TERMS AND CONDITION / INSTRUCTIONS FOR TENDERERS

- Tenders are required to be d opped in the tender box placed in the premises of ADOS office HQ
   Frontier Corps Dera Ismail Khan Cantt
- Tenders could also be submitted through post/ courier service. Tenderer (s) will however be responsible to ensure that his/ their tinder (s) are dispatched in time so as to reach HQ Frontier Corps Dera Ismail Khan Cantt before 10:00 AM or 30 Jul 2022.
- 3. Tenders will be opened at 11 00 AM on the same day in the presence of tenderer (s) or his/ their authorized representative who may care to attend the tender opening.
- 4. Tenderer (s) is / are required to keep his/ their quotations (S) valid for acceptance for ninety (90) days beyond the date of opening of tender (s).
- 5. No tender will be sold on the cate of opening of tenders.
- Appendix "A" enclosed herew :h must be read carefully and returned duly filled in/signed.
- 7. Schedules to the tenders (s) in ust be returned clearly indicating therein price against vehicles which the tenders propose to quote.
- 8. Price (s) quoted must clearly be shown in figures in Pak Rupees. Over writing/ cutting must be avoided as for as possible. If u- avoidable, it must however, be signed by the tenderer (s).
- Tender (s) must be submitted in sealed cover.
- 10. Tender (s) must be addressed to the Inspector General Frontier Corps KP Peshawar.
- 11. Only "ONE" tender set should be enclosed in one cover.
- 12. Conditional bid (s) will straigh: away be IGNORED/ REJECTED.
- 13. Each offer, made in the tender, must be accompany an earnest money in the name of Inspector General Frontier Crops KP Peshawar () Rs. 25% per vehicle of the each quoted bid separately in the form of Bank Draft/ Pay Order/ Call Deposit from any scheduled Bank in Pakistan. No earnest money in cash/ cross cheque will be accepted.
- Tender (s) not supported with earnest money are liable to be IGNORED/ REJECTED.
- 15. Tender (s) are being called for the disposal of Government vehicles. On "AS IS WHERE IS" basis with all faults and discrepancies in their description.
- The sale of vehicles shall strictly be governed as per" Terms and Condition" of this tender inquiry.
- 17. The tenderer (s) is /are warn d to satisfy him/ themselves regarding documents. Log books, Make, Model, year of manufacture, actual condition, damages, missing, and suitability of the Government condemned vehicles.
- 18. Tenderer (s) may inspect the "ehicles/ stores available for disposal in the tender enquiry, in one visit of the site during working hours with the authority of tender set purchased.

- 19. The successful tenderer (s) si all be informed about acceptance of bid (s) through an acceptance letter (sale letter) containing thereir complete instructions to comply with. The purchaser shall be given clear thirty (30) days for the deposition of sale proceed into the Government Treasury/ State Bank of Pakistan, failing which his / their earn ast money would be liable to be forfeited.
- 20. The release order (s) to lift the purchased vehicles from the site shall only be issued after confirmation from the relevant Gove nment Treasury/ State/ National Bank of Pakistan as the case may be. The tenderer (s) are, therefore advised to deposit the sale proceeds/ taxes etc in the treasury/ Bank located in the Provincial Capital.
- 21. When the buyer (s) has/ have paid in full of his/ their purchased vehicles and the released order is issued, the buyer (s) is/ are considered to be the Owner (s) of the vehicles and the Government will keep the vehicles (s) at the risk and cost of the purchaser (s) for the period mentioned in the release Order.
- 22. The successful tenderer (s) vill make his/ their own arrangements to lift the purchased vehicles from the site within specified period
- 23. In case the vehicles are left over for an indefinite period by the purchaser (s) after making payment, the Government reserve with itself, he right to re-sale when those are not claimed within three weeks of the last date of delivery at the risk and cost of the buyer (s) and confiscate his/ their earnest money as well. The original buyer (s) shall not be entitled to any claim on re-sale of goods. He/ they shall be entitled to claim the refund of their deposited amount at the proper form. No interest on the refund of deposited amount shall be paid.
- 24. The vehicles are kept by the Bovernment at the buyer (s) risk after the issuance of release order and it shall not be responsible for any loss or damage to the purchased items due to theft, fire or any other incident.
- 25. The vehicles disposed off to the public, which being Government property at the time of entry into Municipal Limits, have been exempted from the local taxes however octopi/ terminal tax if any shall be payable to the municipal authoritie: concerned directly by the purchaser(s).
- 26. The successful tenderer (s) shall be required to pay General Sale Tax (GST) at Government prescribe rate on his / their quoted/ accepter bid (s) alongwith sale proceed (s). Any other tax, leviable from time to time by the Government at prescribe drates till lifting of the purchased vehicles by the respective purchaser form the site shall be payable.
- 27. The tax payer purchaser (:) shall also have to pay all livable taxes including GST etc., on their purchased goods. He/ they shall, however be entitled to claim adjustment/ refund, of the paid tax, admissible under the rules, from the Income Tax or the sales tax Department as the case may be.
- No interest shall be admissible on any amount deposited with Government.
- 29. The Inspector General reserves the right to accept or reject in full or in part any tender without assigning any reasons. He also reserves the right to waive/ add any of the stipulated conditions in public interest.
- 30. Tender (s) either posted wi shout adequate time to reach the tender box before the scheduled time and date of receipt or posted or lelivered after the scheduled time and date of receipt are called "LATE TENDER (S)". As a rule no notice will be taken for them. Similarly no notice shall be taken on delayed tender (s) which are received on/a ter the date fixed for their receipt.

- 31. Earnest money will be releas :d after lifting the vehicles/ stores by the purchaser and confirmation of reporting authority in this regard.
- 32. No transport will be provided to tenderer (s) to visit various locations, to inspect the vehicles.
