- 3. Tender will be opened in the office of Secretary Procurement / Incharge P&GS, State Life, Zonal Office, Queen's Road, Sargodha on 18th July 2022 at 11:30 a.m. in the presence of bidders or their authorized representatives.
- 4. The Competent Authority may reject all bids / proposals at any time prior to the acceptance of a bid or proposal. The competent authority shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- 5. The Bidders must attach copies of their NTN (ALT) and GST Tax certificates along with quotation.
- 6. The bidder/vendor shall be bound to supply all the items at 1st Floor, State Life, Zonal Office, Queen's Road, Sargodha within (15) days of award of contract / agreement.
- 7. The estimated quantity of items mentioned above may vary at the time of issuing supply order.
