2% of the BOQ cost in shape of CDR / Pay Order prepared from the firm account only in favor of Chief Executive Officer IESCO issued by any schedule bank of Pakistan (having rating A+ or above).

TENDER COST:

EVALUATION CRITERIA:

- a) Registered with Pakistan Engineering Council (PEC) having specialized code EE-04, EE-05, CE-10 & renewed upto 30th June 2023.
- b) Registered with Chief Engineer (S&S/D&S) NTDC Lahore.
- c) Registered with FBR have NTN & General Sales Tax (GST) number.
- d) Registered with Punjab Revenue Authority (PRA).
- e) Engineering Firms / Contractors shall demonstrate annual turnover 2021-22 @ 1.5times the cost of BOQ while Engineering Firms/Contractors already executing projects with IESCO shall be required to demonstrate annual turnover @1.5 times the cumulative cost of BOQ for the running projects in hand along-with BOQ cost of project offered.
- f) Having a relevant experience with successful completion of at least 01 work of similar type/nature within the last 05 years in any DISCO.
- g) Firms with Nil experience of similar nature of work can participate in the bidding process in a Joint Venture with firm holding requisite experience for a specific tender.
