2. The Contractors are required to submit their application to Station Engineer POF Wah Cantt, upto **12-07-2022** for issuance of tender documents along with their complete credentials as

shown at (Par No.4). Contractors who are on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax and duly enlisted with Director Civil Works POF Wah Cantt are eligible to submit their applications.

3. The applications shall be scrutinized and the tender documents will only be issued to the contractors who have sufficient experience in the relevant field and satisfied other special conditions required for job and area. Tenders will be issued to the scrutinized contractors up to **14-07-2022**. Tenders must be dropped / delivered in Black Box placed at Bid Centre (Rabta Hall) near Gate No. 01 on **30-07-2022** up to 1030hrs. Tenders will be opened on the same date at 1100hrs.

4. Contractors having experience, capability and resources may submit the following information/ documents along their application:-


- a. Name of the firm along with postal address, phone & Fax #.
- b. **PEC Registration** in Cat C-6(min) with specialization code.
- c. Similar nature of works in hand along with names and addresses of clients.
- d. Proof of enlistment with Director Civil Works POFs Wah Cantt.
- i. NTN # and evidence of as active tax payers on ATL of FBR for Income tax & sale Tax.

5. Those who fail to provide above mentioned information/documents shall be disqualified.

6. Contractors already registered / working with POFs also fulfill the requirement mentioned in above para-4.

7. The Authority reserves the right to reject any or all the pre-qualification applications under provision of PPRA Rules.
