2. The duration of assignment will be 180 days only, it is expected to be started after issuance of formal letter of acceptance.
3. Method for selection of Consultant will be quality and cost based selection (QCBS).

The Technical bids must be accompanied by a bid Security 2% of bid cost in shape of call deposit by any scheduled bank of Pakistan in favor of Employer and must be delivered in the office of the Executive Engineer PHE & Building Division GB PWD Skardu on or before 13:00 hours, dated on 14th July 2022 and the bids will be opened on the same dated at 13:30 hours, in the presence of all bidders representatives who may choose to attend, at the same address of the office of "SUPERINTENDING ENGINEER CIRCLE OFFICE SKARDU / SHIGAR GB PWD SKARDU"
5. The technical bids without call deposit will be summarily rejected being non responsive. Each envelop should be clearly marked as "Technical bid" and "Financial bid" separately. Technical bids of non-responsive bidders shall be returned unopened.
6. Technical proposals will be evaluated as per approved criteria that shall be part of bidding document.
7. Financial proposal of only those firm whose technical proposal qualified will be opened in due course of time in presence of qualified Consultants / representative who may choose to attend.
8. In case of joint venture, the score of lead partner shall be counted 70% and that associate partner shall be 30%. Both should have to get commutative passing score of 70% or more. More than two partners shall not be allowed.
