- i. The bidding documents will be issued to firm/contractors subject to production of 3% bid security in shape of CDR issued by any scheduled bank in Pakistan and upon production of his/her original CNIC, renewal fee for CFY and Original PEC license.
- ii. Rates quoted below 10% upto 20% of T/S amount, the most advantageous bidder shall have to deposit additional performance guarantee 75% of difference amount within next five working days after opening of bid in shape of CDR from any Scheduled Bank in Pakistan.
