- 3. The bidder / manufacturer must have at least five (5) years manufacturing or supplying experience of similar equipment / material with the same or higher rating and capacity and Two (2) years of successful continuous operational experience.
- 4. The bidding document, in English language, may be purchased by interested bidders from the date of publishing, on the submission of a written application on company's letter head to the above address and upon payment of a non-refundable fee of Rs. 5,000/- the method of payment will be by cash/ bank draft from any scheduled bank of Pakistan in favor of the purchaser. The documents may be collected in person or would be sent by courier services for an additional amount of Rs. 2,000/- for domestic delivery and for international delivery, the documents could be sent by express airmail for an additional payment of US\$ 60 (or equivalent PKR) No liability will be accepted for loss or late delivery of the documents. No tender document will be issued on the tender opening date.
- 5. The bids be prepared in accordance with the instructions in the bidding documents and must reach the Office of Chief Engineer (Development) PMU HESCO, B.No.A-1 HESCO Colony Hussainabad Hyderabad, on or before tender opening/receiving time mentioned as above.
- 6. The tender shall remain open for acceptance for 90-days from the tender opening date and must accompany Bid Guarantee not less than 2% of the quoted bid price, issued by a Scheduled Bank in Pakistan or from a foreign Bank duly counter guaranteed by a Scheduled Bank in Pakistan, valid for 120-days, on Specified Performa.
