- i. Firms/Contractors must have the registration with Pakistan Engineering Council in the relevant category duly renewed for the year 2021-22. Firms applying through joint venture must follow the PEC guidelines and format for JV.
- ii. Firms/Contractors must have the enlistment with Water & Power Department for the financial year 2021-22.
- iii. Firms must have the authorization from original equipment manufacturer (OEM).
- iv. Bids must be accompanied with bid security. Bid security must be attached with the technical bid.
- v. Firm should not be black listed.
- vi. Firm should not be in litigation with Water & Power Department GB.
- vii. Firm should not be declared defaulter by any Government Department.
- viii. Technical and Financial bids should be enclosed in separate envelops clearly elaborated as technical and financial bids.
- ix. Financial bids of only technically responsive firms will be opened.
- x. All the documents must be readable and properly attested. Scanned and vague documents will be rejected.
- xi. Firms should mention the specifications of each item in their technical proposal (if any) and any deviation from the specified specifications will not be accepted.
- xii. Firms must ensure submission of technical and financial proposals in the Office of the Superintending Engineer W&P Circle, Gilgit on or before the date and time mentioned above. No application will be entertained after due date and time.

- iii. Personnel capability of the firm.

- vi. Firms offering sorely unbalance rates must submit the differential amount in shape of CDR along with financial bid.
