2. Scope of Works

Assessment / Structure Integrity Test of existing buildings at PIDC House Karachi includes but not limited to Non-destructive testing, destructive testing, structure analysis, Architectural Drawings, prepare complete reports etc. To find out building load-bearing, damages, deteriorations, seepage and damages due to environment conditions.

It also ensures that the structure components of the building are capable to bear extra load, installation or investigating the impact of any alterations and additions on building structure and face lifting etc.

Also give suitable recommendations about the sustainability of the PIDC Building.

3. Criteria for Bidder Technical Qualification

The bidder should submit documentary proof of the following with their bids,

- a) Company profile with name, address, legal status (i-e. Proprietorship, Partnership, Limited company etc.), year of relevant & general experience of the firm.
- b) Affidavit should be submitted on the stamp paper for the consultant firm not black listed in any government organization.
- c) Completion Certificate(s) of at least 01 project executed in last 5 years, which are similar in scope as per this tender.
- d) Firm must have at least 01 Structure Engineer (Bachelors/Masters) registered with Pakistan Engineering Council (PEC) having 15 years' experience.
- 4. The firms should submit their quote indicating Lump-sum for the whole of the work, inclusive of all type of taxes, transportation, loading-unloading equipment, scaffolding arrangements etc.
