

TERMS AND CONDITIONS:-

1. Interested bidders can only submit their bids online through e-Tender Portal of ML&C Deptt (<https://etender.mlc.gov.pk>), Contractors having valid NTN No, STRN No. and PEC Registration of relevant codes are eligible to apply with proper PEC registration renewal. The cutoff time for submission of online bids will be 1200 hrs dated 04/08/2022 and shall be opened on same day at 1230hrs electronically on the portal. The contractors will be able to see the comparative statement online.
2. E-Tenders without attachment of call deposit/bid bond in favour of the undersigned equal to the earnest money will be rejected.
3. The Cantonment board reserves the rights to demand the analysis of quoted rates to check their Reasonability and workability.
4. The successful contractor shall submit non-judicial stamp paper at his own cost for execution of contract agreement with the CB Sialkot within 07 days after the issuance of acceptance letter.
5. The Cantonment Board/ Executive Officer reserves the rights to reject the tender as per PPRA's Rule No.33 (1) due to any reason thereof.
6. The issuance of work order shall be subject to approval of rates from Board.
7. The validity of tender rates shall be up to 180 days as per PPRA/PEC Rules.
8. Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, user guidance tutorial has been uploaded on the portal.
9. The contractors / bidders, who quoted their bids / rates below MES Schedule of rates 2021 shall submit performance guarantee equal to 8% of the estimated cost under rule 39 of PPRA Rules 2004.
10. In complete / disfiguring / overwriting / by hand / delayed bids shall be declared non-responsive.
11. Any bid received in the contravention of enabling provisions of PPRA Rules, 2004 will be declared Non responsive by the procuring entity.
12. The contractor shall remain inforce till the end of the current financial year or till another term of contract in place of this contract is executed by the Sialkot Cantonment Board whichever is later.
13. Contractor / firms can be participated after the deposit of tender fee as tabulated above, tender fee challan will be obtained from Cantonment Board Office Aziz Shaheed Road, Sialkot Cantt after the publication of the invitation to bid
