



CRITERIA FOR PRE-QUALIFICATION OF WORKSHOPS

For repair, maintenance and purchase of spare parts, tyres and batteries for make and model of vehicles, the sealed bids are invited from registered workshops.

- i. The interested workshops must have minimum 5 years' experience in relevant field.
- ii. The workshops should have their own complete setup i.e. garage, spare parts availability and technical experts in Islamabad/Rawalpindi.
- iii. Telephone/fax facilities etc. in Islamabad/Rawalpindi.
- iv. The workshop should be registered with Sales Tax and Income Tax Department. (Valid documents may be attached).
- v. The interested parties must have sound financial position; proof may be provided.
- vi. Affidavit regarding Non-black listing of workshop/firm on stamp paper at least of Rs.100/- value may be attached with bidding document.
- vii. The set up/workshop, office and technical/professional competency may be assessed by physical visit of tender committee/members of the committee.

TERMS & CONDITIONS

- i. The repair/maintenance work of vehicles will be awarded to the workshops amongst the selected workshops on fulfillment of pre-qualification criteria who quotes lowest rates on need basis.
- ii. The workshop on the panel will be bound to carry out the requisite work on immediate basis when vehicle is referred to it even at odd hours.
- iii. While submitting rates, the workshop should clearly show whether GST is excluded or included in the offered rates.
- iv. The workshop will be bound to return old spare parts in case of replacement with new. Warranty period of each item replaced or repaired, should clearly be mentioned in quoted rates.
- v. The bid validity period will be 30-06-2023.
- vi. The authority reserves the right to accept or reject any application/bid or cancel the process of prequalification without assigning any reason to the applicant/bidder(s) in accordance with Rule-33 of PPRA Rules-2004.
