Walton Cantonment Board being procuring entity invites sealed bids on the basis of MES Schedule of Rates 2014 (amended upto date) on percentage above / below or at par basis for schedule items and market items rate basis for non-schedule items as per "Single Stage Two Envelop Procedure: under Rule 36(b) of PPRA Rule 2004 (as amended upto date) for **supply, fixing, installation and commissioning of 60KW Grid Tied Solar System, for Cantt Public School Tubewell, Walton Cantt Board.** from the PEC Registered contractors / firms having vast experience in installation of Solar Panel System and valid updated registration with Pakistan Engineering Council (PEC) in relevant category and are on Active Taxpayers List of the Federal Board of Revenue.

TERMS AND CONDITIONS:

1. Bidding documents / Tender forms can be obtained on the cost of Rs.2,000/- on submission of applications from the date of publication of advertisement in newspapers / PPRA website but not later than 01 / 08 / 2022.
2. Bidding documents will be deposited in tender box (to be placed in front of office of the Asstt. Secretary, Walton Cantt Board, R.A. Bazar Ahmed Bukhsh Road, Lahore Cantt) on 02 / 08 / 2022 till 1300 Hours. Technical Bid will be opened on the same date at 1330 Hours in the presence of the bidders or their authorized agents. The technical bids will be evaluated by the committee.

3. Financial bid of successful / qualified bidders will be opened after evaluation of technical bid.
4. Tender bidding documents containing invitation to the bid / tender notice, instructions to bidders, Form of Bid, Conditions of Contract Agreement Specifications, Bill of Quantities and Bid evaluation criteria etc. can be obtained on any working day during office hours from the office of Walton Cantonment Board RA Bazar Ahmed Bukhsh Road Lahore on or before closing date / time of tender bid. Price of bidding documents as per Tender Notice (non-refundable) Tender Bidding documents can be downloaded free of cost from WCB website www.wcb.gov.pk.
5. Tender will be issued those firms who have valid PEC registered certificate having appropriate category as described in bidding documents.
6. The “**Technical Proposal / Bids**” of the firms / contractor will be evaluated in accordance with evaluation criteria.
7. The “**Financial Bids / Proposal**” of only technically responsive bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representatives (who may like to attend) in the office of the Walton Cantonment Board on date and time to be notified later on whereas the Financial Bids of technically non-responsive bidders shall be returned unopened to the respective contractors.
8. In case if the lowest bid is less than reasonable rates (10% above/below than the ruling %age as circulated by E-in-C's Branch letter No.2005/22/A/Ruling %age/PP&W/E2 dated 23rd Oct 2020), the lowest bidder shall have to deposit standing security 10% bid amount (refundable after successful completion of the work) in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
9. The validity of tender rates shall be upto 180 days as per PPRA / PEC Rules.
10. Other terms & conditions pertaining to the work can be seen in the office of the Walton Cantonment Board at any working day during office hours.
11. Walton Cantonment Board / Executive Officer reserves the right to accept or reject all tenders (prior to acceptance) as per PPRA's Rules No.33(1) due to any reason thereof.
