

    - Tender on the Firm's letter paid with vendor number.
    - Call deposit worth to **Rs.20000/-** from a scheduled bank.
    - Rates of items must be filled in computerized.
  - The rates of items if not covered in the "**Tender Form**" will be determined in accordance with the retail price fixed by the Chairman Price Control Committee Skardu.
  - Government taxes applicable (if any) will be borne by the Firm/Contractor/Supplier.
