## PAKISTAN POST Government of Pakistan Office of the Postmaster General Central Punjab, Lahore Public Auction Notice

A Public auction on "as is and where is" basis to dispose of Iron, useless furniture, machinery and waste papers etc. available in sufficient quantity at Postal Stock Depot near Dry Port Mughalpura Lahore will be held on 10-08-2022 of at 11:00 AM with following terms and conditions. Interested persons can visit and check auction items on site during office hours.

- The interested bidders will deposit Rs.200,000/- as security in shape of CDR in favour of Postmaster General Central Punjab, Lahore and original CDR will be presented before auction committee.
- 2. The successful bidder should have to deposit 25% of the total bid price on the same day in any Post Office and submit receipt before the auction committee.
- 3. The remaining 75% will be deposited within seven days. Otherwise, 25% deposit will be confiscated.
- 4. The successful bidder will also deposit Government tax under the rules on the spot.
- 5. The successful bidder is bound to lift the auctioned material at his own cost within 07 days after depositing the full amount of bid, otherwise Rs. 2000/- per day will be charged as demurrage charges.
- 6. No employee of the Pakistan Post Office department will be allowed to participate in auction process.
- 7. The decision of the Postmaster General, Central Punjab Circle, Lahore in this regard will be final.
- 8. Any change in plan or cancellation of auction shall be communicated as per PPRA rules.
