Supply, Installation, Testing and Commissioning of Smart Metering for LPG cylinders

Pakistan State Oil Company Ltd. (PSOCL), the country's largest oil marketing company, intends to create a networked LPG distribution system across Pakistan by leveraging IoT and quick commerce solutions. In this regard, PSOCL invites Expression of Interest (EOI) from parties capable of providing Smart Metering for LPG cylinders in Karachi, Pakistan.

The successful applicant(s) are required to submit a complete viable proposal considering the economics and benefits to PSOCL. Smart Meters must be enabled to offer the following features:

- A. Smart Meters should be sized to fit within the shroud of an LPG cylinder and connect to the cylinder valve
- B. Have a communications module to enable real time information flow between the customer/cylinder and the company's servers without human intervention
- C. Allow customers and the company to keep track of their exact gas consumption and enable automatic scheduling of cylinder delivery
- D. GPS enabled in order to provide precise geolocation data., allowing the company to track cylinders and their contents throughout the journey from the filling plant through the distribution channel to the consumer and back, ensuring the integrity of the LPG in the cylinders

Reputable companies with proven track record of providing, installing and/or operating smart metering technology and having sound financial standing are encouraged to participate in the EOI. Interested parties applying for the EOI shall, inter-alia, satisfy the following minimum technology criteria:

"Minimum Criteria"

To enable the aforementioned features, the Smart Meters will have the following capabilities:

- 1. IoT and Machine to Machine connectivity
- 2. High precision metering of gas consumption by the gram
- 3. Monitoring of gas level and consumption by LPG consumer
- 4. Monitoring of gas level and consumption by LPG provider (remote monitoring)
- 5. Location tracking
- 6. Remote on/off capability of gas flow
- 7. Dynamic data integration capability
- 8. Anti-theft and anti-tampering provisions

"Compatibility Criteria"

Given the current cylinder standards in Pakistan, the Smart Meters will be compatible with the following:

- 1. Meters should be installable on steel as well as composite cylinders
- 2. Compliant with DOT 4B for steel cylinders
- 3. Compliant with ISO 11119-3, BS EN14427 and BS EN 12245 for composite cylinders
- 4. Compatible with cylinder valve M26X1.5 with safety relief valve
