Bids in sealed envelope clearly marked "Supply, Installation, Testing and Commissioning of a 400 K VAR Power Factor Corrector at NPF Building, Rose Hill" and reference number MSS/OAB 03/2022-23 should be addressed to the Permanent Secretary, Ministry of Social **Integration, Social Security and National Solidarity** (Social Security and National Solidarity 12th Floor, Renganaden Division) deposited the Bid Box situated at and in Seeneevassen Building, Corner Jules Koenig & Maillard Streets, Port Louis on or before Wednesday 24 August 2022 up to 13 30 hours (local time) at latest.

Bids submitted by mail should be sent to the same address as above with mention "12th Floor Registry" so as to reach by same date and time. Electronic bidding shall not be permitted. Late bids will be rejected.

Bids will be opened in the Conference Room, Level 13 of the **Ministry of Social Integration**, **Social Security and National Solidarity** (Social Security and National Solidarity Division) on the same day at **13 45 hours** in the presence of bidders /bidders representatives who choose to attend.

- (a) accept or reject any bid and;
- (b) annul the bidding process and reject all bids at any time prior to contract award, without incurring any liability towards the bidder.
