The African Union has received financing from the World Bank for the "Africa CDC Regional Investment Financing Project (ACDCP)".

Development Objective of the Project: The Project Development Objective is to support Africa CDC to strengthen continental and regional infectious disease detection and response systems.

#### 1.0. Background

The African continent has greatly suffered from infectious diseases in recent decades. Of special note have been the emerging and re-emerging infections. In addition, the continent has a long history of other emergencies due to civil unrest and natural disasters such as floods. Epidemics and these emergencies are responsible for marked morbidity, mortality, disability and economic loss to individuals and national economies. To mitigate this harm on the continent, the Africa Centres for Disease Control and Prevention (Africa CDC), has been working since the year 2017 to secure a safer, healthier, integrated and stronger Africa, by strengthening capacity of MS to effectively respond to disease outbreaks and other public health threats. The agency's mission is to strengthen the capabilities of Africa's public health institutions to detect and respond quickly and effectively to disease outbreaks and other health burdens through an integrated network of continent-wide preparedness and response, surveillance, laboratory, and research programs. To this regard, Africa CDC has developed an Event Based Surveillance (EBS) framework to guide member states in the establishment of EBS at all levels of the health system.

a) In addition, as part of a cross-divisional collaboration, Africa CDC initiated the Regional Integrated Surveillance and Laboratory Network (RISLNET) initiative to integrate regional laboratory and surveillance network capacity in all five African Union regions in order to rapidly identify and respond to public health threats across the continent. One of the roles of this network is to support member states to implement the Africa CDC Event Based Surveillance (EBS) framework.

#### 2.0. Objective of the Assignment

Support the establishment of an EBS network and an EBS community of practice in the Southern and Eastern Africa regions linked to the Africa CDC RCCs and HQ.

# 3.0.Scope of Work

## The Consultant is expected to undertake the following

- 1. Support the establishment of an EBS network in the southern and Eastern Africa regions linked to the Africa CDC RCCs and HQ.
  - Conduct two (2) regional workshops with EBS stakeholders and surveillance network representatives within the Southern and Eastern Africa regions with the aim of establishing a network of surveillance institutions within the southern and eastern region.
  - Establish an EBS community of practice and regional surveillance network within.
  - Conduct situational analysis on the implementation of EBS in MS within the Southern region.
- 2. Improve data quality access and use in the eastern and southern regions.
  - Use Africa CDC event management system to advocate and strengthen the use of electronic tools to report and analyze surveillance data in MS in Eastern and Southern Africa regions.
  - Use Africa CDC Health information Exchange standards and policy document (HIE) and implementation plan to support the operationalization of HIE in MS and data sharing across MS and RECs in the southern and Eastern region.
  - Develop training package (training module; PowerPoint presentations; participants and facilitators guide) to guide data collation, analysis, trend analysis, data management and developing of reports or summaries.

# 4.0.Evaluation and Qualification Criteria – Firm

## 4.1. Past experience

## The consultant should demonstrate the following experience requirement

- ✓ The assignment will be carried out by a consulting firm with a multidisciplinary team with experience in implementing Event based surveillance, developing training curricula in these areas and particularly with documented experience in implementing these activities for over 10 years.
- ✓ Africa CDC expects the consulting firm to have experience in supporting early warning initiatives or other related public health surveillance, data management and data sharing programs in countries.

✓ Consulting firm should provide excerpts from annual reports, publications, abstracts of conference, or similar documents clearly demonstrating that the organization has the needed capacity.

# 4.2. Financial Statements and relevant documentations

- ✓ The consulting firm should provide a 1-2 page executive summary from three consecutive audit years,
- ✓ Audits should have occurred recently (e.g. within the last 3 years)

# **5.0.Key Experts Qualification and Experience**

The Consulting firm will propose a highly qualified project manager as Team Leader. Specifically, the Consultancy team will include the following key personnel:

## a) Project Manager

## i. Education and work experience:

- a) The project manager should haveMD + MPH/MSc in epidemiology with 5 years of experience in managing/coordinating projects and personnel activities.
- b) Should demonstrate managerial/supervisory experience, in particular in building a multi-disciplinary team and putting systems in place to deliver technical assistance across multiple fields and managing team performance, particularly with proven track record of developing high performance within project teams.
- c) Experience of managing large and complex, multidisciplinary consultancy projects is essential and previous experience in supporting implementation of public health programmes is essential..
- d) Should have experience in engaging countries and conducting similar public health surveillance projects in countries
- e) Expertise in building regional networks; coordinating regional training and conducting country assessments is required.
- f)Fluent in English; working knowledge of French is an advantage. Sound interpersonal and communication skills and excellent presentation skills are required.

## b) Senior epidemiologist with expertise in surveillance and disease intelligence

i. Education and work experience:

- a) The key expert should have MPH or MSc in field epidemiology, with 5+ years' experience related to public health disease surveillance programs in African countries that involve significant partnership and collaboration across multiple partners including host country national programs.
- b) Expertise in the development of national training curricula
- c) The senior epidemiologist will be responsible for implementing surveillance activities as listed in the section "Scope of Work".
- d) English language proficiency, written and oral capability is required. Working knowledge of French is an advantage.

## c) Senior Health information expert

## i. Education and work experience:

- a) The key expert should have a minimum of a Master degree in Health informatics, digital health technology, or other related health sciences or any other related field, and with 5+ years' experience combined and continuous experience in strengthening health information systems, with emphasis on digital health technology, data integration, health information exchange, data access, data processing and data warehousing.
- b) Expertise in development of training curricula and digital application supporting data management and health information exchange respectively is required
- c) The senior health information expert will be in charge of supporting the roll out of the Health information exchange policy and standard document in member states.
- d) English language proficiency, written and oral capability is required. Working knowledge of French is an advantage.

# 6.0. Deliverables, Duration of the Project, Timeframe and Payment Schedule
