#### **SPECIFICATIONS**

#### 1. INTRODUCTION AND BACKGROUND

The National Housing Finance Corporation (NHFC) was established by the National Department of Human Settlements as a development finance institution (DFI) in 1996, with the principle mandate of broadening access to affordable housing finance for the low- and middle-income households.

NHFC is a national public entity, the NHFC adheres to the regulatory framework of the Public Finance Management Act (PFMA) of 1999.

The NHFC provides wholesale funding in the affordable housing market mainly to social housing institutions, non-banking retail intermediaries, privately owned property developers, construction companies and investors. It also provides loans and other form of wholesale funding (equity and quasi equity) to certain niche businesses that are in the affordable housing market.

The NHFC currently uses multiple service providers to access multiple services that are either different in nature or similar and might be providing more or less similar and or overlapping information. These services provide access to ITC credit reports for natural person(s) and juristic person(s), access to area, property and persons reports, access automated valuation/desktop report, and access to property deeds. These services providers are used mostly by the Lending, Credit, Legal and Risk divisions to support the NHFC processes of appraising both new and existing customers with regards to the Incremental housing product, the Private rental product, Social housing product, Subsidy housing product and the Bridging Affordable housing product. Retail credit also uses ITC credit reports to support the current debt management process for the retail mortgage loan product.

A new suitably qualified and licensed service provider provider(s) is therefore required to replace the current contracts with multiple services providers, whose contracts have become irregular.



Provision of these services can either be on a single platform as preferred or can be on multiple platforms if a single platform is not possible.

# 2. PURPOSE OF REQUEST FOR QUOTATION (RFQ)

The purpose of this Request for Quotation (RFQ) is to solicit quotations from potential service providers for the Provision for ITC Credit Reports for Natural and Juristic person(s) Area and or Property reports including Automated Desktop V. This specification document is to provide details in relation to each of the services required by Lending, Credit, Legal and Risk divisions to support the NHFC processes of appraising new funding applications, or managing existing clients, and therefore make more informed decisions. This specification deals with providing information identified as key and therefore considered as essential requirements which should be included in the services by the new service provider.

#### 3. SCOPE OF WORK/KEY DELIVERABLES

#### 3.1 ITC Credit Report – Natural person(s)

An ITC credit report for individuals or natural person(s) provides detailed information on how a consumer has used credit in the past, including how much debt the consumer has and whether or not the consumer settles his or her obligations on time in line with what was agreed with the creditors.

To ensure that this report is comprehensive and contains information that will enable an informed decision making when appraising new funding applications and or when monitoring performance of the existing customers, the report should at least provide the following information;

#### Personal information:

- customer name,
- birth date.
- current and past home addresses,
- current and past phone numbers,



- current and past employers.

#### **Alerts and Public records**

- Verification of customer Identity and identity number,
- Report any anomalies with regards to ID verification,
- Bank account verification
- Verify fraud,
- Indicate consumer credit score,
- Detail any default,
- Detail any judgment,
- Detail any sequestration,
- Indicate any trace alert on consumer,
- Indicate if a consumer is under debt review.

# **Accounts, including NLR**

- Outline a list of consumer's accounts, including revolving credit accounts such as credit cards, and installment loans, such as mortgages or vehicle finance.
- Information should also include;
- creditor names.
- account numbers,
- outstanding balances,
- Arrears amount,
- Payment history,
- Debit order reversal/payment disputes
- Account status (including whether or not the account is past due or written off or closed etc.)
- Performance per account for the last 24 months,
- Summary of symbols used and what they stand for.

#### 3.2 ITC Credit Report – Juristic person(s)

An ITC credit report for juristic person(s) provides detailed information on how a juristic person, as a legal entity and an applicant, has used credit in the past, including how much debt it has incurred and whether the entity settles its obligations on time.

To ensure that the report is comprehensive and will offer the NHFC enough information to make informed decisions when appraising new applications for funding and when



monitoring performance of the existing customers, users should be able to access the following information;

- CIPC directorship
- To check if a director has been declared a delinquent.
- Criminal record of director
- To check if the company is on business rescue.
- See a clear view of the business and its creditors.
- See a full representation of the business in document form.
- See evidence of a business's financial maturity, when presented with other financial documents.
- Verification of bureau information as valid and true, with mandated signatory information
- The ability to prevent fraudulent activity, e.g., bank account detail changes that could result in settlement into incorrect accounts.

# 3.3 Property report

The NHFC uses property reports to assess any risk that might be associated with the area and or property during appraisal of new funding application. This is also used to verify ownership of such property and or obtain estimated market valuation offered with the report.

To ensure that the report is comprehensive and offers the NHFC enough information to enable decisions making during appraisal process for new funding, and when monitoring performance of the existing customers, users should be able to access the following information;

They should be able to access the property report or order automated/desktop valuation report using identity number, or erf number, or physical address, or title deed number, or company registration number, or Company name etc.

- Property ownership current and past
- Provide details of bond holders
- Confirm property description
- Confirm location of property
- Confirm size of property
- Street to Erf Conversions



- Erf to Street Conversions
- Provide title deed number
- Provide SG diagram
- Provide comparable sales of similar properties in the area
- Should offer both commercial and residential property reports
- Feasibility studies
- Show valuation details including both municipal and estimates derived by the services provider using automated valuation or desktop system.

# 3.4 Deed Search report

A Title Deed is defined as the most important document as far as property ownership is concerned. It is a legal document which confirms or proves that one is the owner of a property after having been transferred into ones name. It contains the details of the property such as the full name of the owner/s; date of purchase, purchase price, the size, zoning, etc. The owner can either be a natural person(s) or can be a juristic person(s). The document gets filed at the Deeds offices in various areas according to where the property is situated. Information related to the property is then accessible in a form a deed search normally conducted on a web portal offered by an accredited service provider. The NHFC requires access to the Deed search in order to obtain Deed reports as and when required to access such a report to support its internal processes.

#### 3.5 Trace Services

A Trace service is a service offered by most service providers in the credit bureau space as they are most likely to get the latest contact details of customers from the data they receive from different creditors or members daily. This service therefore assists with providing members with access to the most comprehensive and current information available on consumers and businesses – information that can help minimise losses and increase business' effectiveness in default management. The service is required by the retail unit of the NHFC as they deal directly with the retail mortgage loan customers. As the retail book ages more and more contacts relating to customers become outdated, making it difficult for



the retail administration unit to contact customers especially when they have defaulted in their monthly repayments on the mortgage loans.

## 3.6 Deeds Office Person and Company Searches

These searches are used to assist in obtaining the latest information on natural persons, companies and directors. They also assist in ascertaining the linkages between various persons and their representation as inter alia, directors in companies.

# The following searches should be accessible hereunder:

- Deeds Office Person
- Deeds Office Sequestration
- Company Report
- Director Report
- Spider searches

# 3.7 Further requirements

- Reports should be accessible 24 hours daily.
- Search reports should be returned in real time as the searches are being conducted.
- Search engines or website should allow for multiple logins as different departments will be login into the websites to pull reports for different reasons in line with their business processes.
- Split billing is required to allow different NHFC divisions to manage their own bills.
- The websites where the reports will be pulled from should keep the search results for an ascertainable period at least and this period will be confirmed by the NHFC.
- The system should allow the research results be downloaded and disseminated electronically.
- The NHFC will be the administrator of the account(s) and will therefore add, edit or delete users as and when it is required to do so.

# 4. Lockdown Operations Provisions

- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

# 2. **DEFINITIONS**

- (b) "B-BBEE status level of contributor" means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) "EME" means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **"functionality"** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) "prices" includes all applicable taxes less all unconditional discounts;

#### CERTIFICATE OF INDEPENDENT BID DETERMINATION

This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.

- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
- Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

- <sup>2</sup> Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
