TECHNICAL SPECIFICATION FOR ROAD MARKING MACHNIE – FOR ENQUIRY INTRODUCTION

As part of the road maintenance strategy, BVHOA intend to procure road marking equipment and machinery. This document details some of the key technical requirements for the proposed road marking machine.

1. SCOPE OF WORK

The scope of work must be executed in accordance with BVHOA procurement Terms and Condition and this technical specification.

1.1. Supply of 1x road marking machine with the following features (table 1).

- 7.3. Guarantee the workmanship and general fabrication procedures shall be in accordance with the best modern practice.

8. CORROSION PROTECTION AND PAINTING

- 8.1. Equipment must be painted using an approved painting procedure.
- 8.2. Painting to be guaranteed as per paint manufacture specification used.
- 8.3. Machine to be used outdoors, note conditions in section 5.

9. ASSEMBLY, INSPECTION/TESTING AND OPERATING

- 9.1. Contractor to satisfy himself that all fabrication quality control measures where followed.
- 9.2. Contractor to schedule a test demonstration with Employer before the contract/purchase order can be closed.
- 9.3. Contractor to give comprehensive operating and maintenance manual as part of hand over documentation.
- 9.4. Contractor to give Spire list with brand, part number and current price of spares required.
- 9.5. The *Contractor* must advise on any special precautions that must be taken during lifting, assembly and operation of the equipment provided.
- 9.6. The *Contractor* must provide a detailed lubrication instruction for the equipment if applicable. The specification of the lubrication and frequency of re-lubrication shall also be specified by the *Contractor*
