### 1. BANKSETA BACKGROUND

The Banking Sector Education and Training Authority (BANKSETA) is the SETA for banking and alternative banking industry. It is a statutory body established through the Skills Development Act of 1998 as amended by the Skills Development Act, 26 of 2011 to enable its stakeholders to advance the national and global position of the banking and alternative banking sector. As guided by its mandate, the BANKSETA is as such an agent of transformation and seeks to promote employment equity and broad-based BEE through skills development.

### 2. PURPOSE AND OBJECTIVES OF THE PROJECT

- 2.1. The BANKSETA seeks to appoint a service provider to implement a Leadership Development Programme (LDP) delivered via online learning for a period of three (03) years.
- 2.2 The aim of the LDP is to expose the candidates to best practice in the Banking Sector both locally, in Africa and internationally.

### 3. SCOPE OF WORK

- 3.1 The programme targets individuals from Senior Management level with a potential to be at Executive level and aims to support their Leadership Development in.
  - 3.1.1 Digital leadership and transformation
  - 3.1.2 Future ways of working and leadership efficiency.
  - 3.1.3 Technical bank content
  - 3.1.4 Ethical leadership in an African and global context
  - 3.1.5 Principles around corporate governance in Banking sector.
  - 3.1.6 Technical Consumer Trends Technical skills, platforms and ecosystems, consumer behavior, customer experience from an outside view, etc.

- 3.1.7 Future Skills across business mindset for retention and growth such as.
  - Innovation and Creativity
  - Agility
  - Entrepreneurial Skills
  - Ability to use data to make informed decisions.
  - Risk Management.
  - Critical Thinking.
- 3.1.8 Design Thinking
- 3.1.9 Personal transformation component
- 3.1.10 The programme aims to enroll 400 delegates over a period of three (03) years;
  - - Year 1: 200 delegates
  - - Year 2: 100 delegates; and
  - Year 3: 100 delegates to be nominated by BANKSETA in collaboration with the Banking Sector. Each year intake for this programme will be for approximately 8 months.
- 3.1.11 The successful provider will be required to source subject matter experts (person who possesses a deep understanding of subject) relevant to scope of work from various countries across Africa and Internationally to deliver this programme on an online platform where it is accessible to all stakeholder/banks.
- 3.1.12 It is envisioned that most of the training sessions will be delivered through an online learning platform.

### 3.2 **PROPRAMME DELIVERABLES**

The service provider should perform the following:

- 3.2.1 The service provider should have resources and capability to provide all the services required for this programme, including the ability to form those relationships with African and International Businesses in order obtain learnings for other parts of the world.
- 3.2.2 Provide an online selection / assessment tool to identify the potential and suitable candidates out of a possible pool of approximately 2000 nominees. Proof of your online selection / assessment tool needs to be attached.
- 3.2.3 Provide, plan and implement an online 8 month learning programme.

- 3.2.4 The Programme should be equivalent to NQF L9 competency outcome but need not be an accredited or registered programme. It should be a completely online learning programme and delivered in the platform which accommodates all the participants as well as their organisations.
- 3.2.5 The service provider/s should suggest an online learning platform to be used for these sessions with facilities for break-away sessions, online discussions, tutorial, and other various eLearning methodologies.
- 3.2.6 Any events that may arise as a result of the project implementation, such as a launch, opening – and closing ceremony should be managed in conjunction with the BANKSETA Marketing and Communications Department to ensure brand awareness and compliance with BANKSETA Corporate Identity.
- 3.2.7 The successful bidder will be responsible for the coordination and management of any component (i.e., design, development, and customisation of course content, implementation of the programme, reporting, close out of the programme).
- 3.2.8 Programme should be able to enhance the candidate's performance in leadership and executive positions in a highly competitive Banking environment.
- 3.2.9 The delegate will be required to submit a portfolio of personal learning.
- 3.2.10 Ensure that the required presenters support the participants both at individual and group levels for their learning.
- 3.2.11 Implement assessment methods that will measure acquired competence of the participants and produce such reports.
- 3.2.12 Include the assessment of each candidate's performance.

### 3.3 The provider is expected to;

- 3.3.1 Provide and implement a selection tool for the selection of learners.
- 3.3.2 Provide and implement a Leadership Development Programme that is implemented via online learning
- 3.3.3 Provide a programme with an online African and international immersion.
- 3.3.4 Have Subject Matter Experts with extensive knowledge of the topics.
- 3.3.5 Have the necessary technical experience to deliver the Leadership Development Programme.
- 3.3.6 Have the capacity to deliver the programme through an online platform.

- 3.3.7 Assess the learners.
- 3.3.8 Meet project delivery timelines.
- 3.3.9 Comply with BANKSETA's reporting requirements.
- 3.3.10 Attend all project related status meetings.

### 3.4 The BANKSETA is expected to:

- 3.4.1 Provide a list of delegates to the service provider for selection purposes.
- 3.4.2 Provide the reporting templates.
- 3.4.3 Coordinates the working plan of the steering committee.

### 4. COMPETENCY AND EXPERTISE REQUIREMENTS

4.1 Provide three (03) signed references on client's letterhead of successfully implemented project where the service provider has executed a comparable Leadership Development Programme (letter must indicate relevant topics that were implemented) in the past not older than five (5) years. When using the word 'Comparable' we mean:

4.1.1 Methodology used to deliver an online learning programme of this nature

4.1.2 Training to Senior Manager or Executive as the target audience and

4.1.3 at least 50% topics in the project implemented must be the same in this project

- 4.2 The project team should include Subject Matter Experts (the Subject Matter Expert provides the knowledge and expertise in a specific subject, business area or technical area for a project/programme) to deliver this Leadership Development Programme successfully.
  - 4.2.1 Project team leader must have a minimum of five (05) years' relevant experience.
  - 4.2.2 Minimum of three (03) Subject Matter Expert(s) must have a minimum of five (05) year's relevant experience individually.
- 4.3 The prospective provider should submit CVs for Project team leader and 3 Subject Matter Experts including relevant qualification at NQF 9.
- 4.5 Provide a detailed project plan inclusive of at least the following phases -(Initiation, Planning, Execution/Implementation, Monitoring and Evaluation, Reporting/Closure), milestone and activities, dates, and responsibility.
- 4.6 Programme design.

The service provider should demonstrate a learning map, an assessment methodology as well as sample learning material used when implementing a similar programme (the sample must show at least an overview of the programme and 1 module).

### 5 **DURATION OF THE CONTRACT.**

5.1 The contract will be valid from the contract signing date by both parties for a period of three (03) years.

### 6. PRICING STRUCTURE

- 6.1 The quoted prices will remain fixed for the particular year indicated for the duration of the contract.
- 6.2 The attached pricing sheets (Appendix A) must be completed in full. The BANKSETA will not entertain pricing adjustments after the signing of contract, and it is therefore important that all pricing elements are disclosed.
- 6.3 The pricing sheet should show VAT separately.
- 6.4 The Bidders are therefore required to indicate a total bidding price by completing the pricing schedule provided in full.
- 6.5 Sufficient detail should be included to enable the BANKSETA to fully understand the make-up of the overall pricing.
- 6.6 All pricing assumptions, excluded costs and estimated costs must be clearly documented. The BANKSETA assumes that the pricing document as supplied is complete and covers all costs associated with this project.



The minimum weighting threshold for technical / functional evaluation is 70%. Any bidder scoring less than 70% or 70 weight will be disqualified from further evaluation.

### 12.1. Functionality will be evaluated using the following formula for each criteria $Pf = (So/Ms) \times Ap$

Where:

- Pf is the percentage/weighting scored for functionality for that criterion by Request for Proposal under consideration.
- So is the total score evaluated for the criterion of the Request for Proposal in question.
- Ap is the percentage allocated for functionality for the criterion.
- Ms is the maximum score possible per criterion.
- 12.1.1 Each technical /functional evaluation criteria shows how it will be evaluated out of a maximum of 5 points. i.e Ms =5 points
  The score/points evaluated per criteria is divided by 5 and then multiplied by the weighting of the criteria to arrive at the percentage.
  The BANKSETA will add the percentages calculated for each criterion to arrive at the final total technical/functional percentage or weight.
- 12.1.2 Any proposals not meeting a minimum total weight threshold of 70

**percentage** or 70 weighting on functionality/technical evaluation will not participate in the price/preference points evaluation.

## Pricing will be evaluated using the following formula: 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis: 80/20

Where

**Ps** = Points scored for price of bid under consideration.

Pt = Price of bid under consideration.

**Pmin =** Price of lowest acceptable bid.

### 14. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

The points scored by a bidder in respect of the B-BBEE contribution will be added to the points scored for price to arrive at the overall score. Points will be rounded off to the nearest 2 decimals.

If two or more tenders have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for the specified goals or B-BBEE contribution.

### **15. TENDER CONDITIONS**

- 15.1 BANKSETA reserves the right to withdraw or amend terms of reference by notice in writing by advertising in the media in which the tender was originally advertised prior to the closing date.
- 15.2 BANKSETA reserves the right not to award this tender.
- 15.3 The cost of preparing the applications will not be reimbursed.
- 15.4 BANKSETA reserves the right to verify the information submitted and request for further information during evaluation of the proposal.
- 15.5 BANKSETA shall not be liable for any direct, indirect, consequential, or other losses or damages including loss of profit that may be incurred by any person including, but not limited to, an Applicant, Short Listed Applicant or Successful Applicant, or any director, officer, or associated company thereof, as a result of any reliance on or use of information supplied in response to this tender or as a result of the tender process contemplated in this tender document.
- 15.6 BANKSETA makes no representations, undertakings, or warranties whatsoever to any person in respect of the tender or any information contained in the tender.

### 16. REVIEW PROCESS

- 16.1 In order to evaluate and adjudicate proposals effectively, it is imperative that applicants submit responsive applications. To ensure an application will be regarded as responsive it is imperative to comply with all conditions pertaining to the application and to complete all the mandatory fields and questionnaires.
- 16.2 All applications duly lodged as per the submission requirements will be evaluated in accordance with the stipulated evaluation criteria.
- 16.3 All proposals will go through Bid Evaluation Committee (BEC) for evaluation on functionality.
- 16.4 The proposals from BEC will be tabled before the Bid Adjudication Committee (BAC).
- 16.5 The validity period of proposals is **150 days** after closing.

### **17. REASONS FOR REJECTION**

17.1 Applicants shall not contact BANKSETA on any matter pertaining to the application from the time the application is closed to the time the application has been adjudicated. The results of the Tender will be published by the BANKSETA on portal any other platform which was advertised. Any effort by an applicant to

influence the evaluation, application comparisons or application award decisions in any matter, may result in rejection of the applicant concerned.

17.2 BANKSETA shall reject a submission if the applicant has committed a proven corrupt of fraudulent act in competing for a particular contract.
