2. BACKGROUND

NACOSA through the USAID funded *Community-based Violence Prevention and Linkages to Response* award aims to support South Africa to reach HIV epidemic control (95-95-95) by providing comprehensive support to Adolescent Girls and Young women to prevent HIV and GBV and render comprehensive services to survivors of gender-based violence.

This grants aims to:

1. Support South Africa to reach HIV epidemic control (95-95-95) by providing comprehensive support to 27 600 vulnerable females (10-24 years) to mitigate against HIV acquisition through GBV post violence care response.

2. Develop knowledge and skills to reduce sexual risk, prevent sexual violence and make healthy choices through evidence –informed group interventions with 222 087 adolescent and young women and men aged 15-24 years.

These two core programme elements are implemented in 7 provinces, 14 districts and 54 sub-districts as listed below in Table 1 below:

Pricing
