SPECIFICATIONS

1. INTRODUCTION AND BACKGROUND

The National Housing Finance Corporation (NHFC) was established by the National Department of Human Settlements as a development finance institution (DFI) in 1996, with the principle mandate of broadening access to affordable housing finance for the low- and middle-income households.

NHFC is a national public entity, the NHFC adheres to the regulatory framework of the Public Finance Management Act (PFMA) of 1999.

The NHFC provides wholesale funding in the affordable housing market mainly to social housing institutions, non-banking retail intermediaries, privately owned property developers, construction companies and investors. It also provides loans and other form of wholesale funding (equity and quasi equity) to certain niche businesses that are in the affordable housing market.

Surveys provide insights and information to the organization. These surveys can be used to solicit employee opinions on a variety of issues such as how they felt about some initiatives the company has put in place.

The current COVID-19 pandemic has given the workplace a different meaning. To establish the whether the company, in approving the hybrid model of working, which was aimed at achieving work life balance while still ensuring employee productivity, is achieving what was intended. The company therefore is looking to appoint a company to conduct a bi-annual survey to take a "deep stick" of employees attitudes, feelings and reactions on their experience of working partly remotely and in the office in line with a roster, that will be put in place.



2. PURPOSE OF REQUEST FOR QUOTATION (RFQ)

The purpose of this Request for Quotation (RFQ) is to solicit quotations from potential service providers for the provision of a bi-annual survey on employee experiences working in a Hybrid Model of work (part remotely and part from the office).

3. SCOPE OF WORK/KEY DELIVERABLES

- 1. The main objective of the assignment is to conduct an organization wide (about 131 employees) bi-annual survey on employee experiences working in a Hybrid Model of work (part remotely and part from the office).
- 2. Provide the NHFC with the methodology and implementation plan;
- 3. Report to the Executive Committee of the NHFC on the results of the survey.
- 4. To interpret, report on survey results and make recommendations.
- 5. Provide the NHFC with the methodology and implementation plan of the outcome of the survey;
- To assist the NHFC to design and implement strategies to address potential areas of concern;

Key assumptions

- 1. Skilled in all areas of the implementation and support of the process
- 2. Adequate experience by the tenderer on the above- mentioned programmers.
- 3. Capacity to execute the assignment
- 4. Describe how the vendor will work with the NHFC to design and implement strategies to address potential areas of concern;
