#### 2. PREQUALIFICATION / ELIGIBILITY CRITERIA

2.1 Only those Respondents who satisfy the pre-qualification or eligibility criteria are eligible to submit quotations as per section 3.

#### 3 COMMUNICATION

Respondent/s are warned that a response will be liable for disqualification should any attempt be made either directly or indirectly to canvass any SCM Officer(s) or PRASA employee in respect of this RFQ between the closing date and the date of the award of the business.

#### 4 LEGAL COMPLIANCE

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

#### 5 CHANGES TO QUOTATIONS

Changes by the Respondent to its submission will not be considered after the closing date and time.

#### 6 PRICING

All prices must be quoted in South African Rand on a fixed price basis, including 15% VAT.

#### 11 PROTECTION OF PERSONAL DATA

In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. PRASA agrees that it shall only process the information disclosed by Respondents in their response to this bid for the purpose of evaluating and subsequent award of business and in accordance with any applicable law.

Furthermore, PRASA will not otherwise modify, amend or alter any personal data submitted by Respondents or disclose or permit the disclosure of any personal data to any Third Party without the prior written consent from the Respondents. - 14.1 PRASA requires a validity period of **60 Business Days** from the closing date.
- Respondents are to note that they may be requested to extend the validity period of their response, on the same terms and conditions, if the internal processes are not finalized within the validity period. However, once the adjudication body has approved the process and award of the business to the



successful respondent(s), the validity of the successful respondent(s)' response will be deemed to remain valid until a final contract has been concluded.

#### **SECTION 5**

#### PRASA GENERAL CONDITIONS OF PURCHASE

#### General

PRASA and the Supplier enter into an order/contract on these conditions to supply the items (goods/services/works) as described in the order/contract.

#### **Conditions**

These conditions form the basis of the contract between PRASA and the Supplier. Notwithstanding anything to the contrary in any document issued or sent by the Supplier, these conditions apply except as expressly agreed in writing by PRASA.

No servant or agent of PRASA has authority to vary these conditions orally. These general conditions of purchase are subject to such further special conditions as may be prescribed in writing by PRASA in the order/contract.

#### **Local Content Obligations**

Respondents are to note that the Local Content commitments made by the successful Respondent(s) will be incorporated as a term of the contract and monitored for compliance. Should the successful Respondent fail to meet its Local obligations, non-compliance penalties shall be applicable. Breach of Local Content obligations also provide PRASA cause to terminate the contract in certain cases where material non-compliance with Local Content requirements are not achieved.

Please note that if the items to be used for this work as listed in SBD6.2 cannot be sources from South African based manufactures, bidders should obtain written exemption from DTI. The written exemption from DTI need to be submitted with this request for service.

#### Price and payment

The price or rates for the items stated in the order/contract may include an amount for price adjustment, which is calculated in accordance with the formula stated in the order/contract.

The Supplier may be paid in one currency other than South African Rand. Only one exchange rate is used to convert from this currency to South African Rand. Payment to the Supplier in this currency other than South African Rand, does not exceed the amounts stated in the order/contract. PRASA pays for the item within 30 days of receipt of the Suppliers correct tax invoice.



#### **Delivery and documents**

The Supplier's obligation is to deliver the items on or before the date stated in the order/contract. Late deliveries or late completion of the items may be subject to a penalty if this is imposed in the order/contract. No payment is made if the Supplier does not provide the item as stated in order/contract.

Where items are to be delivered the Supplier:

Clearly marks the outside of each consignment or package with the Supplier's name and full details of the destination in accordance with the order and includes a packing note stating the contents thereof; On dispatch of each consignment, sends to PRASA at the address for delivery of the items, an advice note specifying the means of transport, weight, number of volume as appropriate and the point and date of dispatch; Sends to PRASA a detailed priced invoice as soon as is reasonably practical after dispatch of the items, and states on all communications in respect of the order the order number and code number (if any).

Should you not hear anything in 30 days from the closing date of this request, please consider your bid to be unsuccessful.

#### Containers / packing material

Unless otherwise stated in the order/contract, no payment is made for containers or packing materials or return to the Supplier.

#### Title and risk

Without prejudice to rights of rejection under these conditions, title to and risk in the items passes to PRASA when accepted by PRASA.

#### Rejection

affidavit from CIPC (formerly CIPRO) Self Service Terminals when registering a business or filing annual returns. In these instances PRASA would require proof of turnover as well as proof of ownership. 

#### **SCOPE OF WORK**

#### 1. PURPOSE

The purpose is to procure quality waste removal services for the company to comply with the environmental and health legislations and public expectations. Waste management is governed by the waste management Act 59 of 2009 which has its main objective as waste minimization and waste data collection.

The purpose of this scope is to align waste removal activities of Prasa Cres to those of the National, Provincial and Local government and adhere to by-laws. As a utility of Government parastatal, Prasa can only lead by example and provide leadership in the waste removal for the commuters, business units in the building managed by the company and to the potential investors.

As a company that derives its income on attracting and recruiting commuters and tenants, cleanliness of our facilities is paramount from an aesthetic and presentation point of view.

#### 2. OBJECTIVES

- Improve the environmental cleanliness of the facilities and promote the health and safe environment
- Profile the company as an environmental conscious company committed to the quality health and cleanliness.
- Improve aesthetics of facilities
- Create an environment that will deter pests and rodents
- Establish volumes and statistics of waste streams generated by the users of services



#### 3. THE PRIMARY OBJECTIVES OF CONTRACT

- Procure a once-off services of equipment and plant-hire contractor who will be fully responsible for the rubble and waste removal.
- To contract for cost effective and professional high-quality services.

#### 4. ACTIVITIES

The provision of waste collection service will be informed by the waste generation of the areas involved. Approximately 70% of waste generated by housekeeping activities is general waste and 30% is industrial waste.

To support the use of these long-term assets will require dedicated waste pickers and general workers that will ensure there is no windblown litter or scattered waste within the jurisdiction of the sites.

#### 5. LANDFILL SITE

All Waste and that with commercial value (cannot be reused or recycled) should be transported to the landfill or disposal facilities at contractors' cost.

#### 6. SCOPE OF WORKS

- Waste Management and Rubble Removal at areas listed below:
  - Philippi Station Precinct
  - Khayelitsha Precinct

#### Provision of waste management services for a period of 12 months

- A total of 8 x bins must be supplied at the station's precinct with the vicinity of the areas above.
- Removal of waste twice a week on weekdays, days and schedule to be agreed with the project manager:
- Delivery note to be signed by a Prasa Rail or Cres employee (Supervisor or Manager) on every job done and failure to remove as per schedule will be penalized on pro rata.



- All the waste around the bins should be collected and area should be cleaned after the removal of the skips.
- The preferred bidder will be expected to be ready to provide the required services within 24
  hours after receiving the appointment letter, failing which Prasa reserves the right to cancel
  the contract. (Placing of Bins at the specified areas and pick-up bins at specified days)
- Bins should be sanitized and disinfected after every collection.
