DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

Due COVID-19 the SABC identified a need to source and implement digital signature solution in the organisation. The SABC IT is looking for a solution that can obtain signatures in minutes without any delays, work from anywhere, using any devise, to add staff or team for ease to gathering signatures and to ensure security compliance to secure digital documents.

2. **SCOPE OF WORK**

- Create end-to-end signature signing approach that can be accessed remotely within the SABC secure environment country wide
- Software to facilitate external party signatures especially with contract sign-off
 - In this case the document changes should be confirmed and there is a link to an external party.
- A Digital solution that is more secure in order to get the job done faster and cheaper than paper-based signatures
- Digital solution be capable of sending documents, tracking and managing signature processes within a designed workflow for each type of transaction
- Flexibility of converting end user initials/ signatures onto every page of the contract (remotely and securely attached to access control and personnel numbers)
- If there are changes done on the page or recommendations by a supporter or by an approver, the software is to display the updates and notify the initiator that the document is no longer the same
- Build notifications into the electronic signature workflow to provide complete visibility into the signature process
- Send reminders where required, in the event where the document is with a user longer than 24hours.
- Facility for multiple workflows for the different levels of approvers aligned to the DAF requirements.
- Capable of embedding supporting documents, since in certain cases, requests are accompanied by documents that require signatures
- Capable of reviewing and updating recommendations before submitting to the next level of approval (keep an audit trail of changes)
- Able to approve and reject the submission by sending it on or returning it to previous person and document initiator
- Approver to receive a link via mobile SMS or Email for submission approval or rejection
- Capture the description or objective of the submission

- Reflect the process of approvals of documents on a live updated trackable dashboard
- Separate requirements for internal and external
- External documents will need to be "imported" or uploaded to the solution for the internal sign-offs to happen.
- Solution must allow for export or mailing of document to external parties.
- Signed off documents could be stored in the SABC document management, negating the need to have to keep multiple copies of the document
- A proposed system be able to accommodate use of customised templates, user to sign one page and the signature be automatically applicable to all the pages

3.1 Security

- Signature on the document not to be backdated
- No copying of the signature from previous documents
- No party to change active date of the signing document
- Verification of the signed document i.e. can be utilised by email or cell phone number etc
- Identify a signature to a SABC staff member and their designation and level of authority

3. RFQ Response Information

Effective Date of Bid

Vendors should state in writing in its quotation to the SABC that all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

4. COSTING

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service.

5. DURATION OF THE CONTRACT

The contract will run for 36 Months. (3 Years)

6. EVALUATION CRITERIA

6.1 BBBEE and Price

• The RFQ responses will be evaluated on the **80/20**-point system.

6.2 Technical Evaluation

- 6.2.1 The tender submission will be technically evaluated out of 65 points.
- 6.2.2 All bidders achieving less than the set threshold of 65 points out of 95 points will be declared non-responsive and therefore will not continue to be evaluated for BBBEE & Price Preference.

6.3 Objective Criteria

6.3.1 SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.

7. ADJUDICATION USING A POINT SYSTEM

- 7.1 The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder.
- 7.2 Preference points shall be calculated after process has been brought to a comparative basis considering all factors of non-firm prices.
- 7.3 In the event that two or more bids have scored equal pints, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 7.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 7.5 Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

8. POINTS AWARDED FOR PRICE

The **80/20** preference point system

A maximum of 80 points is allocated for price on the following basis:

- 8.1 Bidders who qualify as EME's in terms of the B-BBEE Act must submit a certificate issued by a verification Agency accredited by SANAS for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates or DTI Affidavit.
- 8.2 Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.
- 8.3 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 8.4 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 8.5 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 8.6 A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the

contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.

8.7 A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

9. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

10. CONDITIONS TO BE OBSERVED WHEN TENDERING

- 10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

- 10.3.1 Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- 10.3.2 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.

- 10.3.3 Award a contract to one or more bidder(s).
- 10.3.4 Accept any tender in part or full at its own discretion.
- 10.3.5 Cancel this RFQ or any part thereof at any time.
- 10.3.6 Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BBBEE & Preference Point system.

11. Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under no circumstances be responsible or liable for any such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection process.

- 1.2 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

2 SUB-CONTRACTING

- 2.1 A person awarded a contract may only enter into a subcontracting arrangement with the approval of the organ of state.
- 2.2 A person awarded a contract in relation to a designated sector, may not subcontract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 2.3 A person awarded a contract may not subcontract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level of contributor than the person concerned, unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.

ANNEXURE "D"

SBD 9 CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
