EARNEST MONEY DEPOSIT

4. Earnest Money Deposit (EMD) of Rs. 36,680/- (Rupees Thirty-Six Thousand Six Hundred and Eighty Only) shall be submitted in the form of Demand Draft drawn from a Nationalized Bank / Scheduled Bank in favour of the Chief Executive Officer, Tamil Nadu Livestock Development Agency, Chennai - 35, payable at Chennai. - 8. The Security Deposit furnished by such tenderer in respect of his tender will be returned to him upon complete fulfilment of warranty period to the satisfaction of the Chief Executive Officer, Tamil Nadu Livestock Development Agency.
- 9. PRICES AND OTHER CONDITIONS

- 11. The rate quoted per unit should be in Indian Rupees. The rate quoted per unit, landed price shall be inclusive of, basic rate, freight, insurance, incidental charges, Goods and Services Tax (GST) etc.
- 12. The rate per unit (landed price) will be the criteria for determining the L1 rate as per Tender Transparency Act and Rules.
- 13. The rate quoted in column 8 of Annexure IX should be for the unit and specification given. The tenderer is strictly prohibited to change or alter specification or unit size given in Annexure – IX.
- 14. The tenderers are required to furnish the break up details of landed price in Annexure X.
- 15. The rate quoted in column 8 of Annexure IX and in column 8 of Annexure X should be one and the same.
- 16. The Unit Rate quoted should not vary with the quantum of the order or the destination.
- 17. The rate offered should be valid for a period of one year from the date of opening of tenders.
- 18. Negotiations will be held with the tenderer who had quoted the lowest rates as per the Tamil Nadu Transparency in Tender Act and Rules.
- 19. The details of item required are shown in Annexure V. The quantity mentioned is only the probable requirement. The final quantity ordered may vary to the extent of 25% either way

- 20. Tenders should be typewritten and every correction in the tender should be attested by full signature of the tenderer with date, before submission of the tenders to the authorities concerned, failing which the tender may be ineligible for further consideration. Corrections done with correction fluid should also be duly attested.
- 21. No handling, clearing or transport charges etc. will be paid. The deliveries should be made as stipulated in the supply order placed with successful tenderer.
- 23. Each tender must contain not only the rate but also the total value of the item quoted for supply in the respective columns. The aggregate value of the item quoted in the tender shall also be furnished.
- 24. The price quoted by the tenderers shall not in any case, exceed the controlled price, if any, fixed by the Central / State Government and the Maximum Retail Price (MRP). The purchaser, at his discretion, will in such case exercise, the right to revising the price at any stage so as to conform to the controlled price or MRP as the case may be. This discretion will be exercised without prejudice to any other action that may be taken against the tenderer.
- 25. To ensure sustained supply without any interruption, the Chief Executive Officer, Tamil Nadu Livestock Development Agency, reserves the right to split orders for supplying the requirements among more than one tenderer provided that, the rates and other conditions of supply are equal.
- 26. The rates quoted and accepted will be binding on the tenderers for the stipulated period and on no account will any increase in the price be entertained till the completion of this tender period.

NOTE

No tenderer shall be allowed at any time on any ground whatsoever to claim revision of or modification in the rates quoted by him. Clerical error, typographical error etc., committed by the tenderers in the tender forms shall not be considered after opening the tenders. Conditions such as "SUBJECT TO AVAILABILITY" "SUPPLIES WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED" etc., will not be considered under any circumstances and the tenders of those who have given such conditions shall be treated as incomplete and for that reason, shall be summarily rejected.

- 27. If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central or State Government or by the tenderer himself, the tenderer shall be bound to inform the Chief Executive Officer, Tamil Nadu Livestock Development Agency, Chennai immediately about such reduction in the contracted prices. Supplies, which do not meet quality requirements and statutory standards, shall render the relevant item liable to be rejected. The tenderer shall also not be eligible to participate in TNLDA tenders for the supply and delivery of **Orthopaedic Surgical Equipment Sets (Basic)** to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu during the subsequent years.
- 32. The decision of the Chief Executive Officer, Tamil Nadu Livestock Development Agency, Chennai, or any Officer authorized by him regarding the quality of the supplied item shall be final and binding.

ACCEPTANCE OF TENDER AND SUPPLY CONDITIONS

- 33. The Chief Executive Officer, Tamil Nadu Livestock Development Agency, reserves to himself, the right to reject the tenders or to accept the tenders for the supply of the item tendered for, in a tender without assigning any reason.
- 34. The Chief Executive Officer, Tamil Nadu Livestock Development Agency will be at liberty to terminate without assigning any reasons thereof the contract either wholly or in part on one month's notice. The tenderers will not be entitled for any compensation whatsoever in respect of such termination.
- 35. The acceptance of the tenders shall be communicated to the tenderers in writing.
- 36. The purchase order shall be placed by Tamil Nadu Livestock Development Agency from time to time or in full during the existence of the contract period based on their requirement and the supplies shall be made directly to the destination indicated in the purchase orders.
- 37. Delivery of Orthopaedic Surgical Equipment Sets (Basic) to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu should be completed within 60 days from the date of receipt of firm order. If delivery of all the Orthopaedic Surgical Equipment Sets (Basic) to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu are not completed within 60 days from the date of receipt of firm order, penalty shall also be levied on the tenderer as specified under penalties. He shall also suffer forfeiture of the Security Deposit. PAYMENT PROVISIONS

- 41. No advance payments towards the cost of supply and delivery of **Orthopaedic Surgical Equipment Sets (Basic)** to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu will be made to the tenderer.
- 42. Payments towards the supply and delivery **Orthopaedic Surgical Equipment Sets** (**Basic**) to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu will be made strictly as per the terms and conditions of the tender.
- 43. Payments towards cost of supply and delivery of **Orthopaedic Surgical Equipment Sets** (**Basic**) to 6 Veterinary Polyclinics and 22 Clinician Centres of Animal Husbandry Department in Tamil Nadu will be considered only on the basis of reports received from officers of the Department of Animal Husbandry to whom the consignment is addressed regarding the quantity received and quality of the received goods against the purchase orders.

PENALTIES

44. If the successful tenderer fails to execute the agreement and or deposit the required security within the time specified or withdraw his tender after the intimation of the acceptance of his tender has been sent to him owing to any other reasons, he is unable to undertake the contract, his contract will be cancelled and the Earnest Money deposited by him along with the tender will be forfeited. He will also be liable for all damages sustained by TNLDA or its participating agencies due to his failure; including the liability to pay any difference between the prices accepted by him and those ultimately paid by the indenting authority for the procurement of the articles concerned. Such damages shall be assessed by the Chief Executive Officer of Tamil Nadu Livestock Development Agency whose decision will be final and the amount so assessed will be recoverable by proceeding

- under the Tamil Nadu Revenue Recovery Act 1864 (*Madras Act. II of 1864 as an arrear of Land Revenue*).
- 45. If any of the goods which the tenderer has failed to supply is not available in the local market or if it is not possible for the Chief Executive Officer, Tamil Nadu Livestock Development Agency to purchase it in time, for the requirements of the institution it will be open to him, or to any persons authorized by him on his behalf to purchase a substitute for the said article/item and to recover the difference in cost from the tenderer, if any, between the price or prices of the substituted articles which may be purchased or the moneys which may have been paid for the same.
- 46. The opinion of the Chief Executive Officer, Tamil Nadu Livestock Development Agency as to the availability of the articles in the local market and as to whether it is not possible to purchase it in time for institution requirement and as to the nature and quality of the substitute to be purchased is final and binding on the tenderer.
- 47. No claims shall lie against the Tamil Nadu Livestock Development Agency, Chennai in respect of interest on Earnest Money Deposit or on Security Deposit.
- 48. If any of the Orthopaedic Surgical Equipment Sets supplied by the tenderer, which have been put to use are subsequently found to be defective, unsound, and inferior in quality or description or are otherwise faulty or unfit for use, then the contract price will be recovered from the tenderer. The tenderer will not be entitled to any payment whatsoever for the contract.
- 49. For infringement of the stipulations of the contract or for other justifiable reasons, the contract may be terminated by the Chief Executive Officer, Tamil Nadu Livestock Development Agency, and the tenderer shall be liable for all losses sustained by the Tamil Nadu Livestock Development Agency, in consequence to the termination which shall be recovered from the tenderer by way of adjusting the amount from the bills payable to him. In the event of such amounts being insufficient the balance shall be recovered personally from the tenderer as per law.
- 50. Non performance of contract provisions such as delayed supplying, non-supplying, supply of substandard goods etc., will result in cancellation of the tender and will lead to disqualification of the firm from participating in the tender during the subsequent year.
- 51. The decision of the Chief Executive Officer, Tamil Nadu Livestock Development Agency, shall be final and binding.
- 52. In the event of any dispute arising out of the tender such dispute would be subject to the jurisdiction of the Civil Court within the city of Chennai.

WARRANTY

- 53. The supplier warrants that the Goods supplied under this contract are new, unused, of the most recent or current models and incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that the Goods supplied under this contract shall have no defect arising from design, materials or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied Goods in conditions prevailing at final destination.
- 54. Warranty shall be for a period of one year from the date of receipt of the Orthopaedic Surgical Equipment Sets and acceptance by the concerned officers at the final destination indicated in the contract.
- 55. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 56. Upon receipt of such notice, the supplier shall, with all reasonable speed, repair or replace the defective goods or parts thereof, without cost to the purchaser.
- 57. If the supplier, having been notified, fails to remedy the defect(s) within the period specified / within a reasonable period, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
