- 1. The maintenance agency is responsible for the safety of departmental materials in and around the blocks.
- The maintenance agency is responsible for attending to any complaint during the contract period.
- 3. Pump Operator is responsible for operating the pump sets for lifting water from well to sump and sump to over water tanks, regulate the water distribution to all the flats without any interruption to the inmates in Day (or) Night times as proposed by the departmental officers and as per their instructions.
- 4. Electrician is responsible for attending to any power fault in the flats and in the common places other than the faults under the preview of the electricity Board, during the Day (or) Night times as proposed by the departmental officers and as per their instructions.

- 4. The name of security personnel employed by the firm along with residential address should be given to department. The department has got over right to instruct to firm to remove any one of the security personnel without any reason and the firm should oblige immediately.
- 5. All the security personnels will come directly under the control of concerned A.E.E. of this division and they should sign in the separate attendance register maintained in the respective sub-division.
