ANNEXURE - I

ELIGIBILITY CRITERIA (Documentary proof to be enclosed)

- The Contractors having registration as First **class** in the Central / State Government Department or the Government undertakings are eligible to participate in the Tender. Contractors may be as a proprietary concern, firm or Limited company.
- Tenderer should have executed **at least one work to a height of minimum 30 metre (100 feet)** (copy of work order to be enclosed) costing more than **Rs.75 Lakhs** during any one of the last four preceding financial years viz **2017-18 to 2020-21**, with similar nature / type of work.
- One person with B.E (Civil) / qualification should be engaged as Site Engineer with site upto the completion of work.
- Average Annual Turnover of **Rs.2.00 crores** in the past four preceding financial years viz **2017-18 to 2020-21** is needed (copy of Audited Balance sheets and Profit & Loss A/c to be furnished). Turnover certified by the auditors to be enclosed for proprietary concerns / firms.
