1. Tamil Nadu Newsprint and Papers Limited (hereinafter referred to as "TNPL") own and operates an integrated pulp and paper manufacturing facility at Kagithapuram in the state of Tamil Nadu. The paper mill manufactures different varieties of paper and is one of the major producers of newsprint and fine papers in India.
2. TNPL intends to replace the Electrostatic Precipitator internals in Boiler#7 at its Mill in Kagithapuram.
3. TNPL invites sealed Bids from eligible Bidders for Supply and Replacement of Electrostatic Precipitator internals in Boiler#7, as per the scope of this Bid Document.

4. Qualification Criteria

The Bidder should be a reputed Manufacturer / Supplier / Contractor who have carried out manufacture / supply, erection, testing and commissioning of at least two (2) Electrostatic Precipitators for Power Boilers / Waste Heat Recovery Boilers of capacity not less than 60 tph each, in the past ten (10) years (Apr 2012- Mar 2022).

The bidder shall provide the documentary evidence for meeting the above qualification criteria.

5. A complete set of Bid Document may be purchased by any interested vendor on the submission of a written application to TNPL and upon payment of a non-refundable fee of Rupees 590/- (inclusive of 18% GST) by Demand Draft in favour of Tamil Nadu Newsprint and Papers Limited, payable at Karur, from the following address:

Alternatively, the bidders can request for the Bid Document through e-mail from the links available in TNPL's website and the fee can be remitted while submitting the bids.

6. A single stage, two-envelope (Technical Bid and Price Bid envelopes) bidding procedure will be followed.
7. In addition to the hard copy of Technical Bid, soft copy shall also be submitted in a Compact Disc.
8. All Technical Bids must be accompanied by a Bid Security of **Rs.1,50,000/-** (Indian Rupees one lakh fifty thousand only) in one of the following forms:
 - (a) An unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in the Bid Document.
 - (b) A Demand Draft in favour of Tamil Nadu Newsprint and Papers Limited, payable at Karur, Tamil Nadu, India.
9. All Bids must be delivered to the office of TNPL not later than 15.00 hours on **03rd May 2022**. Technical Bids will be opened at 16.00 hours on the same day in the presence of the Bidders' representatives who choose to attend. Names of Bidders together with the Nationality of manufacturers and suppliers and such other details as TNPL, at its discretion, may consider appropriate, will be read out. Price Bids of those who qualify in Technical Bids will be opened at a later date, which will be informed to the qualified Bidders.
10. All the envelopes shall bear on the top left corner, TNPL's Bid Document Number and also Bid Due Date, and on the bottom left corner, Bidder's name and address.
11. Bidder shall also superscribe each envelope as "Technical Bid – Unpriced" or "Price Bid" and "Original" or "Copy" as appropriate.
12. TNPL will not be responsible for postal or any other delay and reserves the right to reject any or all the bids at its own discretion.
13. TNPL reserves the right to qualify the bids received and/or reject any or all the bids, without assigning any reasons therefor. Also, TNPL reserves the right to split the order and award the contract to more than one bidder.
14. Bids shall be submitted as specified in Clause 16 of Part 2 (Instructions to Bidders) of this Bid Document and shall not be submitted by any other modes like telegram, telefax or e-mail.
