Cover No.1 (Technical Bid)

- Sales tax clearance certificate less than one year old issued by appropriate authority should be produced in xerox copy.


- d) GST registration certificate, GST clearance certificate less than one year old issued by appropriate authority should be produced in xerox copy.
- e) Pan card issued by appropriate authority should be produced in xerox copy.
- f) Solvency certificate issued by the concerned Tahsildar to the tune of work issued within 5 year with EC issued within one month would be produced in xerox copy.
- g) EMD as notified in the tender notice in the form of Demand Draft drawn in any nationalized bank payable @ Vellore in favour of District Forest Officer, Vellore Division, Vellore
- h) The tenders which are not accompanied the above documents will be summarily rejected by the District Forest Officer, Vellore Division, Vellore.

Cover No.2 (Financial bid)

"The tenderer should produce the following documents in Financial bid cover"

- b) Downloaded tender schedule should be duly filled without any omission particularly while quoting the rate it should be clearly stated both in Numerical and in Words by the tenderer.
