### **FORM OF CONTRACT:LUMPSUM AGREEMENT (ITEM RATE LUMPSUM AGREEMENT)**

#### **1. INVITATION:-**

Sealed Tenders under Two Cover System are invited from eligible contractors (eligibility criteria detailed in Para 3 below) for and on behalf of the State Industries Promotion Corporation Limited, by The Superintending Engineer SIPCOT Limited, Chennai-600 008.

#### **2. PURPOSE OF PRE-QUALIFICATION:-**

The purpose of Pre-Qualification of tenderers for this work, is to ensure that the tenderer eventually selected for participating in the price bid, possess requisite organizational, financial and technical capability to carry out this large magnitude project in a short duration of " 06 " Months (Including Monsoon Period).

#### **3. ELIGIBILITY CRITERIA FOR PARTICIPATION:-**

- (i) The tenderers (Individuals / Firm in Partnership / Private Limited Company / Public Limited Company) registered as Class-I State level Contractors of PWD/Highways/Any department of Government of Tamilnadu/Central Government Department/State Government undertaking with monetary limit above **Rs.75.00 lakhs** and with proven track record in executing major projects are only eligible to participate in the Tender Invitation.
- (ii) The Tenderers in the same "NAME" and "STYLE" should have been in the Civil Engineering Construction field at least for the preceding "FIVE" years.
- (iii) The Tenderers should have satisfactorily completed work such as Road, Drain, Street light and Other Civil works with cost exceeding **Rs.405.81 lakhs (Rupees Four Hundred and Five Lakhs and Eighty One Thousand Only)** under a single agreement in any one of the preceding five financial years including the year upto submission of tender documents by the contractor.

- (iv) The tenderer should have achieved “**Annual Turnover**” of **Rs.1217.42 lakhs (Rupees One Thousand Two Hundred and Seventeen Lakhs and Forty Two Thousand Only)** in any one of the immediate preceding “FIVE FINANCIAL” Years.
- (v) Other minimum criteria required are appended under the heading “Minimum Criteria for Pre-Qualification”.

#### **4. PURCHASE OF TENDER DOCUMENTS:-**

#### **5. DESCRIPTION OF THE PROJECT:-**

##### **SCOPE OF THE PROJECT:-**

1. Formation of Road
2. RCC Storm Water Drain
3. RCC Culverts
4. Providing road separator and road signnanges
5. Street Light

#### **6. PERIOD OF COMPLETION:-**

The period of completion of the project shall be **Six Months (6 Months)** from the date of official handing over of the site to the contractor. The completion period is inclusive of monsoon period also.

#### **8. EARNEST MONEY DEPOSIT:-**

- a) Earnest Money Deposit of **Rs.4,16,000/- (Rupees Four Lakhs and Sixteen Thousand Only)** should accompany the Technical Bid (Cover-I) for the work.
- b) The Earnest Money Deposit should be produced only in the shape of Demand Draft issued by Nationalised or Scheduled Banks drawn in favour of SIPCOT Ltd., Chennai-600 008 in the name of tenderer / Firm Only.

- c) Bank Guarantee will not be accepted towards Earnest Money Deposit.
- d) Technical Bid (Pre-qualification tender application) not accompanied with Earnest Money Deposit will be rejected as Non-Responsive Tender.
- e) If the tenderer withdraws his bid after the acceptance of Price Bid or fails to pay the requisite Security Deposit amount within the time specified in the bid acceptance order, the Earnest Money Deposit produced with the Technical Bid will be forfeited.

**9. SECURITY DEPOSIT:-**

- a) The successful tenderer should furnish Security Deposit for an amount equivalent to 2% (Two Percent) of the contract value, which includes the Earnest Money Deposit already paid along with the Technical Bid, within 15 days (Fifteen days) from the date of receipt of Work Order or Price Bid Acceptance Order.
- b) The Security Deposit minus the EMD amount already produced along with the Technical Bid shall be produced in the shape of Demand Draft or Irrevocable Bank Guarantee for contract period + One year issued by Nationalized or Scheduled Banks drawn in favour of SIPCOT, Chennai-600 008 in the name of tenderer/firm only.
- c) The Security Deposit will be refunded only after the expiration of "One Year" reckoned from the date of completion of the work or soon after the expiration of such period of one year as all defects shall have been made good according to the true intent and meaning hereof, whichever shall last happen.

**10. RETENTION MONEY:-**

- a) In addition to the Security Deposit, SIPCOT shall deduct from the Running Account Bills equivalent to 5% (Five Percent) of the gross total value of each bill as retention money or Performance Guarantee.
- b) 2½% (Two and a Half Percent) of the total value of the work will be retained in the final bill for the work for a period of "One Year" reckoned from the date of completion of the work or soon after the expiration of such period of one year as all defects shall have been made good according to the true intent and meaning hereof, whichever shall last happen.

- c) The Retention Money of 2½ % of the final bill amount less (-) any amount due to SIPCOT shall be refunded to the Contractor after the defects liabilities attached to the contract as detailed in Para 10 (b) supra is over, subject to the following conditions:
- (i) The concerned officer of SIPCOT should certify that no liability is due to be cleared by the contractor.
  - (ii) The contractor should execute and produce an indemnity bond for a further period of "FOUR" years, indemnifying the SIPCOT against any loss or expenditure incurred to rectify the defects if any noticed due to faulty workmanship by the contractor or substandard materials used by the contractor, during the period of "FOUR" years.
- d) The retention money deducted in cash from the running account bills will not bear any interest.
- e) However, the further defects liability period of "FOUR" years shall not be applicable to the damages caused due to normal wear and tear of Roads, water supply works, building works / electrical appliances / lamps.

#### **11. LANGUAGE OF TENDER:-**

The Technical Bid (Pre-Qualification Tender) and all Supporting Documents, Certificates, Evidences and the Price Bid should be submitted in "ENGLISH" only. The Supporting Documents if attached in any other language should be translated in English with the certificate of the "Notary Public" duly certifying that the English translation of the documents is true and accurate translation of the original documents.

#### **12. VALIDITY OF BID (TENDER):-**

The Bid (Tender) shall be valid for a period of 90 days (One Hundred Twenty Days) from the date, notified for opening of Technical Bid.
