Ind.No.1048, Mylaudy which is working under the control of Department of Industries and Commerce invites sealed Tender at this office on 05.05.2022 upto 2.00 pm from competent vendors for Purchase of Well Matured Teak Wood for the purpose of Renovation of Moolasthanam roof in Arulmighu Bhagavathiamman Temple at Mondaikadu in Kalkulam Taluk of Kanniyakumari District. 4. QUALIFICATION CRITERIA

4.1. Tenderer:

- a) The tenderer should either be a proprietorship, partnership, PVT Ltd company, Public Limited Company, as per section 25 under Companies Act, HUF, Co-op Society or Trust in existence in India as per the relevant laws governing them entitled to do business and existing for the past 3 years as on 31.03.2022. The tenderer should provide the relevant certificates of incorporation / certificate of commencement of Business.
- b) The bidder Should have valid PAN number and GST Numbers for their firms.
- c) Dealers are eligible to bid. The Tenderer should be a dealer of Teak Wood at least for a period of 3 years as on 31.3.2022. Copy of the dealership license for tendered items shall be submitted by the bidders. Documents relating to the eligibility conditions have to be submitted along with the tender and if any additional documents are required they should be submitted when they are called for.

d) The dealers should be doing business in India for the last 3 years as on 31.3.2022. The copy of relevant document in proof should be submitted.

4.2 Turnover:

The total turnover of the dealer shall not be less than Rs.50.00 Lakhs (Rupees Fifty Lakhs only) in the last three financial years.

5. EARNEST MONEY DEPOSIT (EMD)

6.1 General Instructions

- b) The tenderers shall be deemed to have satisfied himself/themselves fully before bidding as to the correctness and sufficiency of his/ their bid for the Tender and price quoted in the bid to cover all obligations under this tender.
- c) It must be clearly understood that the terms and conditions and specifications are intended to be strictly enforced.
- d) Successful vendor should supply the well matured Teak Wood log only after the approval by Engineer from Department of Hindu Religious and Charitable Endowments.
- e) Tender once submitted will not be allowed to be withdrawn, altered or cancelled in part or in whole. Any deviation from these conditions will be liable to disqualify the tenderer and the earnest money of concerned tenderer will be forteited.
- f) The tenderer should sign all the pages of the tender document with official seal.
- g) Society will also have the right to claim damages which it may suffer on account of non supply of the material. The Society reserves the right to reject the lowest tender or all the tenders without assigning any reason.
- h) In case of any problem in the matured teak wood, it shall be rectified by the supplier within a period of 2 (Two) days.
- i) The tenderer shall be fully and completely responsible to the Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 for the supply of Teak Wood as per tender condition.
- j) No escalation of cost will be permitted in the Tender throughout the period of Agreement or throughout the period of completion of Tender whichever is later on account of any reasons whatsoever.
- k) Tenders not containing the complete details as above are liable for rejection.

6.2 Clarifications on the tender

6.3 Amendments to the tender

- a) The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 may amend the tender wherever it is felt that such an amendment is absolutely necessary.
- b) Amendment to tender may also be given in response to clarifications by prospective tenderers and it is solely at the discretion of the Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048. Any amendment to the tender will be uploaded in the website and made available and it is the responsibility of the tenderer to verify the amendments if any and get the amended documents before the submission of the tender provided no such change could be effected 48 hours prior to the time fixed for opening of the tender.
- c) The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 at his discretion may or may not extend the due date and time for the submission of tender on account of amendments.

6.4 Language of the Tender

The tender prepared by the tenderer as well as all the correspondence and documents relating to the tender shall be in English language only. In case any document is in other language, a copy of English translation shall be provided with the tender. The supporting documents and printed literature furnished by the tenderer may be in another language provided they are accompanied by an accurate translation in English language, in which case, for purposes of interpretation of the tender, the English translation shall govern. The Tenders received without such English translation copy of the supporting documents are liable to be rejected. For any wrong translation the tenderer is responsible.

6.5 Tender form not transferable

The tender form sold to a tenderer is not transferable. It should not be used by others and if used by others it will not be accepted. Similarly photo copy of the tender form will not be accepted.

6.6 Downloaded Tender Form

a) The tender document can be downloaded through website on A4 size paper only and computer print alone should be submitted in the form of a booklet. Submission of tender document in any other form will be rejected. The cost of the downloaded Tender application for Rs.2,000/- should be furnished in the form of

- D.D drawn @ in favour of The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 along with the Bid.
- b) Tenderer shall download corrigendum, if any, published subsequently and submit along with the tender; otherwise the tender will be rejected. It is the responsibility of the tenderer to check whether any corrigendum has been given by the Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 subsequently in the website / newspapers.
- c) The tenderer shall submit downloaded tender documents in original without any change/ addition/ deletion and correction. If any change / addition/ deletion is detected at any stage after the award of the tender, the EMD remitted by the tenderer will be forfeited without any intimation and their name will be black listed from participating in subsequent tenders. Besides, they will also be prosecuted.
- d) A declaration should be given by the tenderer along with the tender in the form given in **Annexure-V**.

7. SUBMISSION OF BIDS

7.1 Signing of tender

- a) The tender shall be typed or written in indelible ink and shall be signed by the tenderer or a person duly authorized to bid the tenderer to the Tender. All pages of the tender shall be signed by the person or persons authorized to sign the tender.
- b) Any alterations, corrections or overwriting shall be treated as valid only if they are authenticated by full signature by the person or persons authorized to sign the tender.
- c) The tender once submitted cannot be modified or amended or withdrawn. No documents of a supplementary nature will be received after submission of tender.

7.2 Bid Prices

The Bidder shall indicate on the appropriate price schedule form (Annexure I), the cost of bid price of the goods it proposes to supply under the tender.

7.3 Mode of submission

- a) The tender must be dropped in the tender box kept in the Office of General Manager, District Industries Centre, Nagercoil on or before the due date and time. The tender will not be received personally.
- b) The tenders received after the due date and time will not be considered and will neither be opened. Tenders in unsealed covers or in incomplete shape or through facsimiles (Fax) or by electronic mail will not be accepted.
- c) A tender once submitted shall not be permitted to be altered or amended.

8. OPENING OF TENDERS

- a) The Tender outer cover and price bid cover including EMD cover will be opened at the prescribed date and time in the presence of tenderers or their representatives who choose to be present. The representatives of tenderers who attend the tender opening must produce their Identification proof and authorization letter from the companies.
- b) If the date fixed for opening of tender happens to be a Government holiday for any reasons, the sealed tenders will be received and opened on the next working day at the appointed time.
- c) The Tender outer cover will be opened on 05.05.2022 @ 3.30 p.m. following which the tender document will be evaluated. After the completion of evaluation, the qualified tender of the price bid opening on the same day.
- d) The Tender should be filled in the Price Bid format as given in the Tender.
- e) The Price Bid should contain a single price, if more than one price / optional prices are found in the price bid, the lowest price alone will be considered for evaluation. The prices should be quoted both in words and figures.

9. EVALUATION OF THE PRICE BID

- a) The tender will be evaluated in accordance to the Tamil Nadu Transparency in Tenders Act 1998 read with the Tamil Nadu Transparency in Tenders Rules 2000 by Purchase Committee.
- b) In a tender where all the tenderers are from within the State of Tamil Nadu or where all the tenderers are from outside the State of Tamil Nadu, the Goods and Service tax shall be included for evaluation of the price.
- c) In a tender where the tenderers are both from the state of Tamil Nadu as well as from outside the State of Tamil Nadu, the incidence of Goods and Service tax will be treated by evaluation of the prices as per relevant rules in consonance with the Tamil Nadu Transparency in Tenders Act 1998 read with the Tamil Nadu Transparency in Tenders Rules 2000.
- d) Financial bid will be opened on the date and time mentioned in the tender document at the Office of General Manager, District Industries Centre, Nagercoil by Purchase Committee. The Bidder with the lowest rate would be awarded with the purchase order, subject to the fulfilment of tender conditions given in this tender document.

10. SPECIAL TERMS

Purchase Committee reserves the right to negotiate with the tenderer whose offer is the lowest evaluated price for further reduction of prices

11. ACCEPTANCE OF THE TENDER

- a) The final acceptance of the Tender is entirely vested with Purchase Committee who reserves the right to accept or reject any or all of the Tenders in full or in part. The Tender Accepting Authority (Purchase Committee) may also reject any tender for reasons such as changes in the scope of procurement, new technologies, court orders, accidents or calamities and other unforeseen circumstances.
- b) After acceptance of the tender by Purchase Committee, the tenderer shall have no right to withdraw his tender or claim higher price.

11.1 Letter of acceptance

- a) a) After acceptance of the tender The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 will issue letter of acceptance (LOA) only to the successful tenderer(s).
- b) Letter of acceptance will be issued for the entire quantity allotted with instructions to execute agreement for the entire quantity pending issue of Purchase Order.
- c) The delivery period will be counted from the date of issue of the "Purchase order" / or as stated in the supply schedule which will be decided at the time of issue of supply order.

11.2 Payment of security deposit (SD)

- a) The successful tenderer will be required to furnish security deposit equivalent to 5% (five percent) of the purchase order value inclusive of earnest money deposit amount either in the form of demand draft obtained from any of the Nationalized bank / scheduled bank drawn in favour of The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 or in the form of unconditional irrevocable bank guarantee valid till 31.12.2022 within one week from the date of receipt of letter of acceptance.
- b) The security deposit will be released to the successful tenderer after completion of the entire supply. The security deposit held by The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048, till it is released to the successful tenderer will not earn any interest thereof.

c) The security deposit will be forfeited if a tenderer withdraws the tender during the period of tender validity specified in the tender or if the tenderer fails to sign the agreement. Further the security deposit will be forfeited for non-adherence of any of the tender conditions and for the non-Supply of ordered quantity either in full or in part thereof.

11.3 Execution of agreement:

- a) The successful tenderer is required to execute supply agreement for the fulfillment of the Tender in a Rs.100/- Non-Judicial stamp paper within three days from the date of receipt of letter of acceptance issued by the Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048.
- b) The successful tenderer shall not assign or make over the Tender, the benefit or burden thereof to any other person or persons or corporate body for the execution of the Tender or any part thereof. The Purchase Committee reserves their right to cancel the purchase order either in part or full if this condition is violated.

11.4 Release of firm purchase order

After payment of security deposit and successful execution of the agreement "Firm Purchase Order" for the supply of Teak Wood will be issued to the successful tenderers by the Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048. The supply and payment will be based on the Purchase Order only.

11.5 Refund of earnest money deposit

The earnest money deposit will be refunded to the unsuccessful tenderers after the finalization of tender and issue of firm purchase order to the successful tenderer within a reasonable time. EMD amount of successful tenderer will be refunded on payment of Security Deposit. Alternatively EMD can be adjusted towards payment of Security Deposit.

11.6 Supply and Delivery

Supply of the Teak Wood must be commenced as per the specification given in tender and the supply should be completed within 45 days from the purchase order.

The Successful vendor should deliver the Well Matured Teak Wood Log at Kalkulam Taluk, Kanniyakumari District after the approval by Engineer from Department of Hindu Religious and Charitable Endowments.

12. PAYMENT TERMS

- a) No advance payment will be made or no letter of credit shall be established.
- b) Complete Payment will be made after satisfactory delivery at designated locations in the Districts/Blocks, based on the certifications by the authorized officers and acceptance report.
- c) The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 reserves the right to recover any dues from the tenderer which is found on a later date during the audit after final settlement is made to them. Accordingly, the tenderer is liable to pay such dues to the The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048.
- d) The details of Excise duty, Customs duty and GST wherever applicable paid by the supplier to Government of India and State Government respectively should be furnished in the succeeding month before 25th.

13. PENALTY CLAUSE

The Secretary, The Kanyakumari Wood Carvers Industrial Co-operative Society Ltd. Ind.No.1048 will have the right to black list the Supplier for any breach of tender / agreement terms at any point of time.

14. FORCE MAJEURE

- a) Force Majeure means an event beyond the control of the Supplier and not involving the Supplier's fault of negligence and not foreseeable. Such events may include, but are not limited to, acts of the nature such as fires, floods, epidemics etc., and other events such as wars or revolutions, quarantine restrictions, freight embargoes etc.
- b) If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the causes thereof within 7 days of such event. Unless otherwise, directed by the Purchaser in writing, the Supplier shall continue to perform his obligations under the Tender as far as is reasonably practical, and shall seek all reasonable alternative means for performance of the Tender.
- c) In the event of Force Majeure, the delivery period will be extended for a period equivalent to the period for which Force Majeure event was in existence. For this period the Supplier shall not be liable to pay penalty.

d) However, the price quoted by the bidder and accepted by the Purchaser shall remain firm during such extended period. For the matter of clarity, Force Majeure shall not have any bearing on the price.

15. TERMINATION OF TENDER

15.1 Termination for Default:

- a) The Purchaser may, without prejudice to any other remedy for breach of Tender, by written notice of default with a notice period of 15 days, sent to the Supplier, terminate the Tender in whole or part, (i) if the Supplier fails to deliver any or all of the goods within the time period(s) specified in the Tender, or within any extension thereof granted by the purchaser; or (ii) if the Supplier fails to perform any of the obligation(s) under the Tender; or (iii) if the Supplier, in the judgment of the Purchaser, has engaged in fraudulent and corrupt practices in competing for or in executing the Tender.
- b) In the event the Purchaser terminates the Tender in whole or in part, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, the goods and services similar to those delivered and the Supplier shall be liable to the Purchaser for any additional costs for such similar goods. However, the Supplier shall continue the performance of the Tender to the extent not terminated.

15.2 Termination for Insolvency

The Purchaser may at any time terminate the Tender by giving written notice with a notice period of 7 days to the Supplier, if the Supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Supplier, provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to the Purchaser.

15.3 Termination for Convenience

The Purchaser may by written notice, with a notice period of 15 days sent to the Supplier, may terminate the Tender, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of work under the Tender is terminated, and the date upon which such termination becomes effective.

16. JURISDICTION

Any dispute arising out of non-fulfillment of any of the terms and conditions of this tender shall be subject to the jurisdiction of the court in the city of Nagercoil.
