Single cover system shall be adopted for the above work. SIPCOT, Chennai-8 and dropped in the tender box available in SIPCOT Head Office, Egmore, Chennai-8 on the due date in person either by the tenderer or by their representatives. Tender received without EMD and belated tenders are liable for rejection without any intimation. EMD is liable for forfeiture if the tenderer withdraws his tender after acceptance of tender or if he does not pay the S.D. within specified time.

The tender will be opened by the Superintending Engineer on the date and time stipulated above. If the last date of receipt of tender happens to be a Public Holiday, the tenders will be received and opened at the above said time on the next working day.
