- 4.28. In case of any accident involving the employees of the successful tenderer the compensation and the penal consequences under the relevant Act shall be borne entirely by the successful tenderer. If the Union has to incur any expenditure in that regard, the same shall be reimbursed by the successful tenderer.
- 4.29. The employees so engaged by the successful tenderer under no circumstances could be considered for appointment in the union on the ground that they have worked as a contract labourer.
- 4.30. The employees of the successful tenderer cannot claim any benefits or amenities extended to union employees.
- 4.31. All sums found due to the union under or by virtue of these presents shall be recoverable from the successful tenderer under the provisions of Tamilnadu Co.op Societies Act 1983 or in any other legal manner as the Federation may deem fit, if the same could not be recovered by adjusting from the security deposit or the bills of the tenderer, due to any reason.
