TERMS AND CONDITIONS:

1. An earnest Money Deposit of Rs.2,500/- (Rupees Two thousand five hundred only) will be payable by Bank Draft in favour of "The Assistant Inspector of Police(Modern)". While the Earnest Money will be refunded to unsuccessful bidders after completion of process, the successful bidder should not be included in the bidding price.
2. The highest bidder (H1) will be required to make payment of whole amount, by a bank draft/ pay order in favour of AIG (Modern), Chennai - 04 within five working days from the date of issue of a letter by the Department requesting to make a full payment, failing which the EMD will be forfeited and the bid will be treated as cancelled and the bidder shall be barred from participating in future tenders of this department.
3. The items will have to be removed within 7 (seven) working days by the successful bidder at his own transport/expense immediately after realization of the payment, failing which a penalty of Rs. 500/- per day will be imposed.
4. Attested copy of PAN/GST No. of the firm, while submitting the tender must be attached.
5. A copy valid registration certificate issued by the Central Pollution Control Board or State Pollution Control Board or District Pollution Control Committees or Tamil Nadu e-Waste Policy must be enclosed with the bid.
