The approximate quantity as given in the tender schedule item wise in accordance with terms and conditions with details in the Tender Schedule.

## **V. TENDER TERMS AND CONDITIONS**

1. Sealed Tenders are invited from the Manufacturers/ Dealers only for the supply of Dyes/Sodium Hydrosulphite – Pharma Grade 88% to 92% (Zinc based) for processing of cotton as well as manmade fabrics / blends.
2. The details of Dyes/Sodium Hydrosulphite – Pharma Grade 88% to 92% (Zinc based) required and the Tender documents (Format for Technical and Price Bid) are enclosed herewith.
3. The expected quantities mentioned in the schedule are based upon the average consumption of the previous years and it may vary i.e. increase or decrease or dropping the purchase according to the work orders received from the Government bodies and others and therefore, the tenderer is liable to supply the requirement of the material without any break.
4. **The rates quoted and finalized shall be constant without any change. Those who are willing to accept this condition only should participate in the tender.**
5. The tenderer should send the samples of 250 grams for Dyes and 5 Kgs for Sodium Hydrosulphite – Pharma Grade 88% to 92% (Zinc based) to the office of the mills before tender opening i.e.,03.06.2022. The samples are subject to lab testing for quality aspects. Based on the quality the tender will be awarded.
6. Each and every supply should be subjected to Lab testing for quality aspects. After testing, if there is any quality difference, the supply will be rejected and materials will be returned at suppliers cost.
7. Any damages arise during the processing due to inferior quality of supply, the entire damages /loss to mills will be recovered from the concerned supplier.
8. Supply should be made within the shortest period possible soon after placing orders. In case of non-supply or delay in supply, the extra cost if any incurred by the mills towards the alternate purchase and loss due to shortfall in production will be debited to the concerned suppliers account. In case of repeated violation of this condition, the tender security deposit will be forfeited and the tenderer will be blacklisted.
9. The rates should be inclusive of all taxes like GST, excise duty, transit insurance; freight charges, Octroi and any other levies etc. (Second sales) and all delivery should be F.O.R. Erode/Mills.
10. **The Price Bid should be quoted in the enclosed Format only and if quoted in any other form will be rejected. All the tender pages should be signed by the tenderer or authorized person with office seal.**
11. Payment shall be made normally within 30 to 45 days from the date of supply, by means of crossed cheque or demand draft (demand draft commission at supplier's account) subject to availability of funds. 2% Discount will be debited for the payment made before 45 days.

  - iv) The tenderer should quote the freight charges up to the Mills. The packing quantity should be as per Mills requirements.
