- 1. Eligibility:** A Bidder (a) shall not participate in more than one Quotation; (b) shall not have conflict of interest as defined in the Bank's Procurement Regulations; and (c) should not have been (i) temporarily suspended or debarred by the World Bank Group in compliance with the Bank's Anti-Corruption Guidelines and its Sanctions Framework (ii) blacklisted / debarred by tender inviting authority or by any other State Government or Central Government department/Organization during the period of blacklisting / debarment. (d) shall be a Manufacturer / Dealer / Distributor / Wholesaler for Supply of Fodder seeds / Agricultural inputs.

5. Conformity of Goods: Bidder shall furnish, documentary evidence that the Goods conform to the technical specifications and standards, as relevant for example catalogue, warranty/ guarantee etc. of the manufacturer.

(a) Certified / truthful label seeds will be accepted. A attested copy of the seed certificate issued by the competent authority should be attached along with the quotation.

(b) In case of certified seeds, the bags along with the certification tag issued by the Seed Certification Department or equivalent will be accepted.

(c) In case of truthful label (TFL), the quotation will be accepted with the following conditions:

i) On receipt of the fodder seeds, lot / batch wise check (Test) sample will be taken by the Animal Husbandry Department and sent for analysis to any Seed Testing Laboratory of Government Seed Certification Department in the State of Tamilnadu. The cost towards analytical fees should be borne by you.

ii) In the event of failure of check sample during the analysis at Seed Testing Laboratory due to poor germination percentage, purity, etc, you have to take back the entire lot / batch of the supply and replace with fresh lot / batch at your expense.

6. Qualification of the Bidder: (a) Bidder should have supplied goods of similar type (& capacity) up to at least 100% quantity in any one of last 3 years. Details of supplies made during the last 3 years shall be submitted in the specified Proforma.(Proforma for performance statement). Attested copy of invoices noted in performance statement should be attached). Atleast 40 % of the quantity in case of equipment offered for supply should have been in successful operation for at least one year as on date of quotation opening.

(b) Supplies for any particular item in each quotation should be from one manufacturer only. Quotations offering supplies from different manufacturers for the same item in the quotation will be treated as non-responsive.

7. Validity of Quotation: Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

8. Signing of Quotations: The name and position held by each person signing the quotation and related documents must be typed or printed below the signature.

9. Quotation Submission: The Letter of Quotation shall be filled, signed and submitted along with the Price Schedules that shall be furnished using the Forms available in this document.

10. Opening and Evaluation of Quotations: The Quotations will be opened on the specified date, time and place.

(a) The Purchaser shall examine the quotation to determine whether the quotation (i) has been properly signed (Clause 8); ii) meets the eligibility criteria (Clause 1); (iii) conforms to all terms, conditions, technical specifications, warranty/guarantee etc.; and (d) the bidder has accepted the delivery schedule (Purchaser's Requirement Form 1).

- (b) Only Quotations that are substantially responsive to the RFQ document, and meet all Qualification Criteria shall qualify.
- (c) The evaluation shall be based on the total price of Goods and Related services at project site including GST and any other taxes, which will be payable on the finished goods at the time of invoicing.

11. Award of contract: The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- a) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- b) The bidder whose quotation is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- c) 100%Payment shall be made within 60 days after delivery of the goods. Payment of GST and other taxes payable for the goods at the time of invoicing, although already included in the total cost, will be at actual or the rate/amount of these taxes specified in the supply order, whichever is lower.
- d) Normal commercial warranty/ guarantee shall be applicable to the supplied goods. The quoted medicine / item should have a minimum expiry period of one year from the date of supply. Government Supply – Not For Sale should be printed on the item to be supplied.
