1. Eligibility:

A Bidder

- a. shall not submit more than one Quotation for the item
- b. shall not have conflict of interest as defined in the Bank's Procurement Regulations; and
- c. should not have been temporarily suspended or debarred by the World Bank Group in compliance with the Bank's Anti-Corruption Guidelines and its Sanctions Framework

2. Clarifications & Amendments:

If the Purchaser receives any request for clarification of this RFQ Document, it will upload its response together with any amendment to this document, on the www.tenders.tn.gov.in portal for information of all Bidders. Bidders should check on the portal, for any amendments to the terms and conditions.

3. The Quotation shall comprise the following:

4. **Quotation Prices**

- a) The contract shall be for the full quantity of the item, as specified in the Price Quotation Form.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) GST and any other taxes, which will be payable on the goods at the time of invoicing in connection with the sale, shall be shown separately. If these are only stated to be extra, such quotations are liable to be rejected. Wherever these taxes are not shown, these will be assumed to have been included in the quoted price.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices shall be quoted in Indian Rupees only.

5. **Conformity of Goods:** Bidder shall furnish documentary evidence that the Goods conform to the technical specifications and standards, as relevant for example catalogue, etc. of the manufacturer.

6. **Qualification of the Bidder:**

- a. Bidder should have supplied goods of similar type, up to at least 100% quantity in any one of last 2 years. Details of supplies made during the last 2 years shall be submitted in the specified Proforma.
- b. Supplies for any particular item in each quotation should be from one manufacturer only. Quotations offering supplies from different manufacturers for the same item in the quotation will be treated as non-responsive.
- c. **Quotation shall be submitted by the bidder owning a semen station and producing Genomic semen doses in their semen production station.**
- d. **The semen stations from which the Genomic semen doses are offered should have been implementing the Minimum Standard Protocol for semen production**

of Government of India, graded 'A' by the Central Monitoring Unit of the Government of India in the latest evaluation (*Certificate to be enclosed*).

- e. All the bulls in the semen stations from which semen doses are offered should have been screened by accredited laboratory as per MSP and shall be free from Tuberculosis, Johne's disease, Brucellosis, Infectious bovine Rhinotracheitis, Trichomoniasis, Genital Campylobacteriosis and Bovine Viral Diarrhoea during the past one year (*Testing results to be enclosed*)
 - f. The bulls from which semen doses are being supplied should have been genomically evaluated by authorized agency and the certificate to this effect and the Genomic breeding value should be submitted.
- 7. **Validity of Quotation:** Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.
 - 8. **Signing of Quotations:** The name and position held by each person signing the quotation and related documents must be typed or printed below the signature.
 - 9. **Quotation Submission:** The Letter of Quotation shall be filled, signed and submitted along with the Price Schedules that shall be furnished using the Forms available in this document.
 - 10. **Opening and Evaluation of Quotations:** The Quotations will be opened on the specified date, time and place.
 - 11. The Purchaser shall examine the quotation to determine whether the quotation
 - a) has been properly signed (Clause 8);
 - b) meets the eligibility criteria (Clause 1);
 - c) Conforms to all terms, conditions, technical specifications, etc.; and
 - d) the bidder has accepted the delivery schedule (Purchaser's Requirement Form 1).
 - 12. Only Quotations that are substantially responsive to the RFQ document, and meet all Qualification Criteria shall qualify.
 - 13. The evaluation shall be based on the total price of Goods and Related services at project site including GST and any other taxes, which will be payable on the finished goods at the time of invoicing.
 - 14. The individual breed wise price would be evaluated and the lowest eligible bidder for each breed wise will be awarded the contract.
 - 15. **Award of contract:** The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- (a) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- (b) The bidder whose quotation is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).
- (c) The goods shall be delivered to the consignee officers with the invoices raised in the name of the Chief Executive officer, Tamil Nadu Livestock Development Agency, for certification and submission to TNLDA office.
- (d) Payment shall be made immediately/or within 15days on the receipt of certified invoices from the consignee officials after delivery of the goods. Payment of GST and other taxes payable for the goods at the time of invoicing, although already included in the total cost, will be at actual or the rate/amount of these taxes specified in the supply order, whichever is lower.

16. Normal commercial warranty/ guarantee shall be applicable to the supplied goods

17. Supply: Supply of the items shall be effected in full within 60 days of the receipt of firm orders.

3. Sperm concentration not less than 20 million motile cells per straw pre freeze and not less than 10 million motile live spermatozoa per straw post thaw
4. Packed in 0.25ml French mini straw with colour coding as per MSP India
5. Post thaw motility :Minimum 10 million motile cells at thawing as per CASA IVOS II
6. Intact acrosome: Greater than or equal to 65%
7. Bacterial load: less than 5000 CFU per ml.

Spec for Genomic Bulls (Pedigree to be enclosed)

8. Semen shall be from genomically tested sires
9. Sires should be registered with the respective breed association internationally
10. Sires' daughter average standard lactation shall be above 11000 kg in case of Holstein Friesian and 6000 kg above in case of Jersey.
11. Sire's daughters average milk fat shall be above 3.5% or above 350 kg of standard lactation yield in case of Holstein Friesian with total protein also in excess to 330 kg per lactation
12. Sire's daughters' average somatic cell count (SCC) and calving ease (CE) should be mentioned
13. Reliability of breeding value for production characters of milk fat and protein shall be more than 70%
14. Sire shall have good type characters udder and feet conformation
