- 5. Should possess Lab accreditation to National Accreditation Board for testing and Calibration Laboratories (NABL) for conducting coal analysis.
- 6. Should have carried out sampling and analysis for a minimum quantity of 20 lac tons per Annum in the past 3 years (Details to be provided as per the format enclosed as **Annexure**)
- 7. Should depute chemist having the qualification of M.Sc (Chemistry) with 5 years experience in sampling and analysis of coal, out of which at least two years in your laboratory.
- 8. Should depute chemist and samplers one day before the arrival of vessel in port and rake/truck at TNPL site (Unit-I, Cement Plant and Unit-II) for sample collection and testing. The Tenderer should have a lab/office at discharge port.

Necessary documents on the above qualifying requirements are to be submitted along with the application by the Agencies and based on the credentials, enlistment would be done.

The Tenderers should ensure that all the required documents are furnished for meeting the qualifying factors. Tenders received without the relevant documents would summarily be rejected
