5. FOR SPECIAL ATTENTION:

a)Applicant should be Registered as a class I contractor in WRD/PWD and registered Small Scale Industrial Unit in Department of industries and commerce of the Government of Tamilnadu and ministry of micro small & medium enterprises, Government of India.

- b) Applicant should be Registered under factories act, Employeesstate insurance corporation & Provident fund organization
- II.The Applicant in the same name and style, should have been in the Hydro mechanical equipment's, StructuralManufacturing Construction field at least for the past FIVE YEARS.
- 5. The Contractors who fulfill the Pre-qualification criteria are alone eligible to be considered in the Item wise rate system tender.
- 6.The Pre qualification tender and Item wise rate price tender in separate sealed envelopes will be received by the Superintending Engineer., WRD., Upper Cauvery Circle., Salem 7 on 10.06.2022upto 3.00 PM

7. PERIOD OF COMPLETION:

The period of completion shall be 12 (**Twelve**) calendar months(Including rainy season) from the date of handing over of the site to the successful Tenderer.

8. EARNEST MONEY DEPOSIT:

- 8.1Earnest Money Deposit of Rs.3,47,000/- (Threelakh and forty seven thousand only) must accompany with the Pre Qualification document for this work.
- 8.2 The Earnest money deposit may be produced in the shape of any one of the following forms.
- (i)Demand Draft/ BankersCheque issued by Nationalized or Scheduled Banks drawn in favour of the Executive Engineer, W.R.D., Mettur Dam Division, Mettur Dam.

- (ii) Small Savings Scripts / Deposits Accounts, KisanVikasPatras, NSC duly pledged in favour of the Executive Engineer, W.R.D., Mettur Dam Division, Mettur Dam.
- (iii) Bank Guarantee will not be accepted towards Earnest Money Deposit.
- 8.3 Pre-Qualification tenders not accompanied with the prescribed Earnest Money Deposit and which is not in acceptable shape will be rejected as Non Responsive tender at the time of opening itself.

9. SECURITY DEPOSIT:-

- 9.a. Successful tender has to furnish security deposit for an amount equal to **2% of the contract value including E.M.D.** which will be converted into security deposit.
- 9.b. If the tenderer fails to pay the requisite security deposit amount within the specified period of time, the Earnest Money Deposit paid with the tender will be forfeited.
- 9.c. On evaluation of Tender, if it is found that, over all quoted amount of the Tender is less than 5% to 15% of the value put to Tender, the contractor has also to enclose an additional security deposit at 2% of the estimated value. If the Tender discount exceeds 15% to 20% of the value put to tender the contractor has to enclose an additional security deposit of 50% of the difference between the quoted amount and estimated amount.
- 9(d) If the over all quoted amount of the tender is less than 20% of the value put to tender, then the tender deciding authority will be ascertain the nature of work, the capacity of the tenderer, the competition for this work and feels that this work can be completed by the quoted tenderer with this less value, in such case the contractor has to enclose additional Security Deposit of 50% to the difference between the quoted amount and estimated amount.

If the tender deciding authority feels that the quoted contractor will not able to execute the work, in such case the tender will be rejected.

The Additional Security Deposit Collected for the minus tenders referred above will be returned only along with security deposit as per agreement condition.

9.(e).If the Tender excess exceeds 20% of the value put to tender then the Tender will be rejected.

9(f)ADDITIONAL CONDITIONS FOR CONTRACTOR'S SPECIAL ATTENTION.

- **1.** The contractor is bound for recovery under Revenue Recovery Act for any liabilities under this contract.
- 2. "If at any time the Executive Engineer shall be of the opinion that the contractor delaying commencement of the work or violating any conditions of the progress of

work, as defined in the tabular statement" rate of progress in the Articles of Agreement" the Executive Engineer will so advise the contractor in writing and at the same time demand compliance. It the contractor neglects to comply with such demand, within 7 days after the receipt of such notice it shall be then or at any time thereafter be lawful for the Executive Engineer to impose penalty or forfeiture on this contractor from the Deposit or to the determine the contract.

- 3. "All the rates quoted in the tender, shall be inclusive of GST payable under the GST as amended from time to time and that the contractor is responsible to file the GST return and pay the amount of tax as demanded by the C.T. Department. No request for payment of GST separately in addition to tendered rates due to any plea of subsequent levy or increase in tax will be entertained vide also clause 38(2) of General conditions to contract.
- 4. Any amount fallen due from the contractor on account of this contract even after recovering from the bills for this work and any other contract awarded to the contractor, then the amount is liable to be recovered under the provisions of Revenue Recovery Act.
- 9.(g). The Security Deposit in the shape of irrevocable Bank Guarantee will also be accepted. The Security Deposit should have a validity period of at least24 (**Twenty four**) Months from the date of signing of agreement.
- 9.(h). In addition to the aforesaid security deposit, the Executive Engineer shall deduct from the running account bills, an amount equivalent to 5% (**Five percent**) of the total value (including GST amount for all the running account bill) as retention money.
- 9.(i). The Security Deposit shall be released only after the defects liability period reckoned from the date of completion of work.
- 9.(j). 2 ½ % (Two and a Half Percent) of the total value of the work, will be retained in the final bill of the work for a period of 24 months, reckoned from the date of completion of the work or as soon as after the expiration of such period of 24 Months (Twenty fourMonths) as all defects shall have been made good according to the true intend and meaning here of, whichever shall last happen.
- 9.(k). The Retention money of 2 ½ (Two and a Half Percent) of the total value of contract after deducting any amount due to the department, shall be refunded to the contractor, after the defects liabilities attached to the contract is over (as per para 9(j) above) subject to the following conditions.

(i) The **Executive Engineer, W.R.D., Mettur Dam Division, Mettur Dam.** should certify that no liability is due from the contractor.

<u>10. LANGUAGE OF PRE – QUALIFICATION AND PRICE TENDER :</u>

Tenders shall be offered only in the prescribed forms in "ENGLISH" only.

11. VALIDITY OF PRICE TENDER:

The Price tender shall be valid for a period of **90 days** (**Ninety days**) from the date, notified for opening of tender. The tenderers shall be prepared to give due extension of validity until such time as may be required till the acceptance or decision of tenders by tender accepting authority.

<u>I MINIMUM CRITERIA FOR PRE - QUALIFICATION</u> <u>Criteria – 1- Registration</u>

1 (a) The Applicant should be a registered contractor of TamilNadu State Public Works Department/Water Resources Departmentunder Class I State Level) with monetary limit Rs. 75.00 Lakhs (Rupees Seventy Five Lakhs) and above.

The Applicants in the same name and style should have been in the Hydro Mechanical equipments manufacturing field at least for the Past "Five" Years. The tenderer should be well established and reputed Hydro Mechanical equipments manufacturing Contractor, registered as a legal entity in India for a minimum period of Five (5) years and having experience of minimum Five (5) years.

- (i)Applicant should be Registered as a **Small Scale Industrial Unit** in Department of industries and commerce of the Government of Tamilnadu and ministry of micro small & medium enterprises, Government of India.
- (ii) Applicant should be Registered under factories act, Employees' state insurance corporation & Provident fund organisation

Evidence to be produced for I (a) Attested copy of Registration Certificate issued by the Registering Authority, registering the name of applicant as class I Contractor in Tamil Nadu State Public Works Department/Water Resources Department and live list certificate.

(i) Attested copy of Registration of SSI Unit and

Registered with Industries and Commerce Department of Government of Tamil Nadu or Ministry of micro small & medium enterprises Government of India for the particular activity. The activity should be highlighted in the Certificate.

- **1.1** The Applicant Should remain in the same "NAME" and STYLE" in the field of Hydro Mechanical equipments, structural Manufacturing and construction at least for the Past (5) Five Years.
 - 1.2 If a registered single contractor has changed and registered his / her 'Name and Style' to a Company/ Partnership Firm within the period of past Five Years, is also be considered for this criteria, subject to the condition that the registered individual Contractor is one of the partner and having experience in Civil Engineering / Electrical Engineering field for at least 5 (FIVE) Years.

- **2.** 1 The Applicant shall be solvent to an extent of at least Rs. 30.00 Lakhs (Rupees Thirty Lakhs Only) on immovable properties in his / her/ firm's name. Obtained from revenue authorities.
- **2.2.**In addition to the above, the applicant should furnish the copy of same Solvency Certificate, as furnished to the Registration Authority at the time of registering in his / her / their name, as contactor in PWD along with the Encumbrance Certificate on that property, which should be authenticated by the Notary Public, since the initial solvency certificate furnished by the applicant at the time of registration as contractor in PWD is the fundamental document for registration.
