### CONDITIONS FOR PARTICIPATION IN THE TWO COVER PRE-QUALIFICATION TENDER SYSTEM

- The applicant should remain in the same "name and style" in the Civil Engineering construction field at least for the past "FIVE" years.
- The applicant should be a registered contractors in TNSCB under Class –I and above or Government Departments / Government undertaking / Public Sector Undertaking, registered as a legal entity in India with a monetary limit of Rs.75.00 lakhs and above.
- The applicant should produce "SARAL" as produced to Income Tax Department and respective Balance Sheet and details of Sales Tax Registration and the Sales Tax Verification Certificated are obtained for the past "FIVE" years.
- The applicant should furnish the details of major building works including other civil and electrical works completed by him / her / them during the past "FIVE" years.
- The applicant should not have any of his contract terminated / rescinded due to breach of contract on part of the applicant during the past five years by any agency.
- To qualify for award of the contract, each bidder in its name should have in the last five years. Been in the business of residential / commercial development in India. Achieved minimum an annual financial turnover below mentioned during any one of the last five year in India. (1.5 x contract value)

- 9 **Bid capacity = (AxNx1.5 B)** where,
  - **A** = Maximum value of civil engineering works executed in any one year during the last five years (updated **to 2021- 2022** (price level) taking into account the completed as well as works in progress.
  - **N** = Number of years prescribed for completion of the works for which bids are invited.
  - **B** = Value, at **2021- 2022** price level, of existing commitments and on-going works to be completed during the **next 3 months** (period of completion of the works for which bids are invited)
- Note1: The statements showing the value of existing commitments and on-going works\* as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in charge, not below the rank of an Executive Engineer concerned/Director or equivalent and the same should be in originals.
- The applicant shall have a project Manager and Site Engineer with Degree (or)
  Diploma (in Civil / Electrical Engineering) holders with minimum field experience prescribed.
- The bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
  - i) The qualification of tender evaluation shall be done as a pass & fail basis against criteria furnished.
  - ii) Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/or -record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.; and / or participated in the previous bidding for the same work and had quoted unreasonably high bid prices and could not furnish rational justification to the employer.

#### 12 AMENDMENT OF BIDDING DOCUMENTS

- (a) Before the deadline for submission of bids, the Superintending Engineer may modify the bidding documents by issuing addenda.
- (b) Any addendum thus issued shall be part of the bidding documents and shall be communicated in writing to all the purchasers of the bidding documents. Prospective bidders shall acknowledge receipt of each addendum in writing to the Superintending Engineer.
- (c) Modified amendments if any will be put up in Government Web site. www.tenders.tn.gov.in

#### 13 Language of the Bid

All documents relating to the bid shall be in the English language.

#### 14 <u>Documents comprising the Bid</u>

The bid submitted by the bidder shall comprise the following:

- (a) Volume 1 (cover A)
- (i) Pre-qualification
- (ii) EMD
- (b) Volume 2 (Cover B)
  - (i) Price schedule

#### 15 Bid Validity

Bids shall remain valid for a period not less than ninety days after the deadline date for bid submission. A bid valid for a shorter period shall be rejected by the Superintending Engineer as non-responsive.

In exceptional circumstances, prior to expiry of the original time limit, the Superintending Engineer may request that the bidders may extend the period of validity for a specified additional period. The request and the bidders' responses shall be made in writing.

#### 16 Bid Security

The Bidder shall furnish, as part of his Bid, a Bid security in the amount as shown in IFB for this particular work. This bid security shall be in favour of **The Executive Engineer**, **Salem Salem**, **Tamil Nadu Urban Habitat Development Board** and may be in one of the following forms:

Banker's cheque, or Demand draft from nationalized / scheduled bank located in India in favour of The Executive Engineer, Salem Division, Tamil Nadu Urban Habitat Development Board Payable at Salem.

- Any bid not accompanied by an acceptable Bid Security and not secured as indicated above shall be rejected by the Superintending Engineer as non-responsive.
