Terms of Reference

WASH Consultant (Jal Jeevan Mission, Tamil Nadu) with UNICEF support

1. BACKGROUND:

Jal Jeevan Mission (JJM) has been launched by Ministry of Jal Shakti, Government of India. JJM the flagship scheme of the Government seeks to provide Functional Household Tap Connections in all rural households of India and also to promote the holistic management of local water resources. The goal is that every home gets drinking water in adequate quantity i.e. 55 litre per capita per day (lpcd) on a regular and long-term basis. As per DDWS as on 31st March 2019, only 18.33 percent of rural households in the country, have Piped Water Supply (PWS). It has been planned to provide around 14.60 Crore rural households with functional household tap connection (FHTC) through Jal Jeevan Mission (JJM) by 2024.

In Tamil Nadu, there are 37 Project Districts (except Chennai) with 388 Blocks, 12,525 Village Panchayats and 79,395 habitations. As on 01.04.2022, out of the total Households of 1,26,89,045 in Tamil Nadu, 52,99,034 households were provided with FHTCs. The balance households have been planned to be covered before March 2024.

The JJM emphasises on community participation and making it as a movement- a Jan Andolon. As per JJM guideline, at grass root level, local communities especially women are to be encouraged to participate and take ownership of water resource management, water supply and grey water management and its reuse. UNICEF as the sector partner organization and will play critical role as partner of Government for providing technical support for community managed water supply system in Tamil Nadu. To achieve the objective of providing improved and sustainable drinking water services in rural communities through JJM, it is important to focus on water quality management, source sustainability, sustainable service delivery (operation and maintenance), building professional capacity and strengthening decentralized governance in collaboration with TWAD Board, Directorate of Rural Development and Panchayat Raj and Panchayat Raj Institutions. As requested by the Mission Director, Jal Jeevan Mission & Managing Director TWAD Board, UNICEF agreed to provide a WASH Consultant (Jal Jeevan Mission) to support at the State Project Management Unit (SPMU) in rolling out of JJM schemes.

2. PURPOSE OF ASSIGNMENT:

Consultant to Provide technical support for coordination, planning and implementation of Jal Jeevan Mission (JJM) in collaboration with SWSM, JJM, TN, including supportive and handholding support to focus districts of Tamil Nadu through:

Leadership and Coordination

Support the strengthening of sector coordination by facilitating regular coordination meetings.

Implementing JJM guidelines and monitoring

Strengthening decentralized governance in water resource management, water supply and grey water management and its reuse through Panchayat Raj Institutions and community involvement.

3. OBJECTIVES:

- Support in planning and review of State Annual Action Plan for Jal Jeevan Mission.
- To support in improving its capacity of state and district officials and Implementation Support Agency (PLFs) to scale up community management water supply system under JJM.
- To support strategic coordination with TWAD Board and Rural Development & Panchayat Raj Department (RD&PR Dept) on successful implementation of JJM.
- To provide hand holding support to District PMU JJM, PLF members in implementation of community managed water supply system.

4. MAJOR TASKS TO BE ACCOMPLISHED:

- Technical support to SPMU, JJM, Chennai for strengthening the institutional arrangement at all level for JJM roll out and planning of community managed water supply system.
- Support in developing Annual Action Plan based on JJM Guidelines.
- Support to develop Capacity Building of various stakeholders for scaling community management water supply system, grey water management, water conservation, rain water harvesting, etc.,.

 Support to develop IEC strategies at District and State Level and issuance of IEC quidelines.

- The total score is 100. Minimum overall qualifying score is 60.

 the minimum score in each of the above sub-criteria will be considered for this
 assignment.
- The financial proposal of the qualified candidates alone will be considered for evaluation and unqualified persons will be rejected by all means.
