## **INSTRUCTIONS TO BIDDERS FOR SUBMISSION OF E-TENDER CUM AUCTION**

**Bidders are requested to read the terms & conditions for participating in this E-tender cum auction .**

**1. The URL for online bid submission in e-tender and subsequent forward bidding is <https://tntenders.gov.in>**

**2. Registration:**

**2.1** The process involves bidder's registration with Tamil Nadu Government e-procurement portal. For this, the bidder may visit the above URL and click on "Online Bidder Enrollment" and fill up the registration form with their details and submit.

**2.2** The bidder shall create their own user id and password during enrollment and bidders are advised to keep note of the same. Then the Digital Signature enrollment has to be done with the e-token, after logging into the portal.

**2.3** For this the bidder should possess Class II or Class III signing type digital certificate. The e-token/ DSC (Digital Signature Certificate) may be obtained from one of the authorized Certifying Authorities. For detailed guidance about DSC, the bidders are advised to go through "Information about DSC" link at <https://tntenders.gov.in>.

**2.4** Only after registration, the bidder can submit his bids electronically. Electronic submission of Bid over the internet will be done. Bidders are required to make their own arrangement for bidding from a computer connected with Internet. Bids will not be recorded without Digital Signature.

**2.5** The e-token that is registered should be used by the bidder and should not be misused by others.

**2.6** DSC once mapped to an account cannot be remapped to any other account. It can only be In-activated.

#### **4. System Requirement:**

- i. Operating System - Windows XP-SP3 & above
- ii. Internet browser - IE7 and above.
- iii. Signing type digital signature (class II or III)
- iv. JRE 7 update 79 (Preferred file- Windows X-86 Offline) and above to be downloaded and installed in the system.  
To enable ALL active X controls and disable 'use pop up blocker' under Tools→Internet Options→ custom level.

#### **5. E-tender cum auction:**

The bidders shall first submit their E-tenders and then take part in the auction. when the live auction is opened during the stipulated date & time. Only **auction ie., increased rates will be allowed in the bidding.**

#### **6. Submission of E-tender:**

- 6.1 The bidders shall submit their electronic-bids online by entering the required details and uploading the required documents as detailed in **clause '5' of "Terms and Conditions of Tender"**.
- 6.2 After downloading / getting the tender schedules, the Bidder should go through them carefully and then submit the documents as per the tender document, otherwise, the bid will be rejected.
- 6.3 The bidder shall read the terms and conditions and accepts the same to proceed further to submit the electronic-bids.
- 6.4 **The BOQ template (Price Bid Template) must not be modified/replaced by the bidder** and the same should be uploaded after filling the relevant columns, else the bid is liable to be rejected. Bidders are allowed to enter the Bidder Name and Values only.
- 6.5 The bidder, in advance, should prepare the bid documents to be submitted as indicated in the tender schedule and they should be in PDF/XLS/RAR/DWF formats. If there is more than one document, they can be clubbed together.
- 6.6 The bidder has to submit the tender document(s) online well in advance before the prescribed time to avoid any delay or problem during the bid submission process.
- 6.7 **Only the files which are "attached" with the e-tender shall be considered during evaluation of the Bids. Files which are not attached to the e-tender shall not be considered for evaluation.**
- 6.8 Since the uploaded documents have to be downloaded for evaluation of bid, bidders are advised to upload clear scanned copies.

- 6.9 There is no limit on the size of the file uploaded at the server end. However, the upload is decided on the Memory available at the Client System as well as the Network bandwidth available at the client side at that point of time. In order to reduce the file size, bidders are suggested to scan the documents in 75-100 DPI so that the clarity is maintained and also the size of file also gets reduced. This will help in quick uploading even at very low bandwidth speeds.
- 6.10 **The bidder should see that the bid documents submitted should be free from virus and if the documents could not be opened, due to virus, during tender opening, the bid is liable to be rejected.**
- 6.11 It is important to note that, **the bidder has to Click on the "Freeze Bid" Button, to ensure that he completes the Bid Submission Process. Bids which are not Frozen are considered as Incomplete/Invalid bids and are not considered for evaluation purposes.**
- 6.12 At the time of freezing the bid, the e-Procurement system will give a successful bid updating message after uploading all the bid documents submitted and then a bid summary will be shown with the bid no, date & time of submission of the bid with all other relevant details. The documents submitted by the bidders will be digitally signed using the e-token of the bidder and then submitted.
- 6.13 After the bid submission, the bid summary has to be printed and kept as an acknowledgement as a token of the submission of the bid. The bid summary will act as a proof of bid submission for a tender floated and will also act as an entry point to participate in the bid opening event.
- 6.14 Upon successful submission of e-tender, the Bidder shall receive a bid acknowledgement mail from the system automatically in the registered email id/mobile No.
- 6.15 Successful bid submission from the system means, the bids as uploaded by the bidder is received and stored in the system. System does not certify for its correctness.
- 6.16 All the data being entered by the bidders would be encrypted at the client end, and the software uses PKI encryption techniques to ensure the secrecy of the data. The data entered will not be viewable by unauthorized persons during bid submission and not viewable by any one until the time of bid opening. Overall, the submitted bid documents become readable only after the tender opening by the authorized members.
- 6.17 During transmission of bid document, the confidentiality of the bids is maintained since the data is transferred over secured Socket Layer(SSL) with 256 bit encryption technology. Data encryption of sensitive fields is also done.

6.18 If after making Final Submission of e-tender and before the scheduled closing time for Bid submission, if a bidder wishes to make changes in his Bid, it can do so by clicking the **"Resubmit"** option.

6.19 After final submission of Bid and before the scheduled closing time for Bid submission, if a bidder wishes to withdraw his bid, it can do so by clicking the **"Withdraw Bid"** option. **By withdrawing a bid, a Bidder will lose the opportunity to re-submit his Bid against the same e-tender.**

## **7. Auction :**

7.1 The date & time period of auction will be intimated through the e-procurement portal/ email after evaluation of the E-tenders.

7.2 The Highest (H1) price quoted in the e-tender will be fixed as the base price for the Auction. The bidding will be forward and the bidders shall quote higher rates.

7.3 **The Lowest bidder quoted in the e-tender will be eliminated from participating in the auction process as detailed in clause 6.4 of Tender Specification.**

7.4 The bidders shall submit their bids in the Forward bidding as detailed in **clause '6' of "Terms and Conditions of Tender"**.

7.5 The bidder shall participate in the Forward bidding , only for the lots for which he has quoted in the e-tender. Bidding for the lots, not quoted by the bidder, will not be opened for him. The bidders who have not participated in the e-tender cannot participate in the Auction also.

## **8. General:**

8.1 If there are any clarifications, the same may be obtained online through the e-Procurement Portal or through the contact details given in the tender document. Bidder should take into account of the corrigendum published, if any, before submitting the bids online.

8.2 The **TANGEDCO** will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders due to local issues.

8.3 **The time that is displayed from the server clock at the top of the tender Portal, will be valid for all actions of requesting bid submission, bid opening, Auction etc., in the e-Procurement portal. The Time followed in this portal is as per Indian Standard Time (IST) which is GMT+5:30. The bidders should adhere to this time during bid submission.**

8.4 **E-tender / Auction cannot be accessed after the due date and time for bid submission.**

- 8.5 The bidder shall submit the bid documents and bid in Auction online mode only, through <https://tntenders.gov.in> portal. Offline documents will not be handled through this system (Only EMD shall be submitted in offline and the same shall be scanned and uploaded in on line).
- 8.6 All notices and correspondence to the bidder(s) shall be sent by email only during the process till finalization of tender with forward bidding. Hence the bidders are required to ensure that their email address provided at the time of registration is valid and updated. Bidders are also requested to ensure validity of their DSC.
- 8.7 Bidders are advised to see the web site regularly to remain updated with latest information to ensure that they do not miss out any corrigendum / addendum uploaded against the said E-tender cum Auction. **The responsibility of downloading the related corrigendum, if any, will be that of the bidders.**
- 8.8 For further assistance please go through the link "[Bidders Manual Kit](#)" in the portal.
- 8.9 During bid submission process in E-tender cum Auction, the bidder should allow to run a application JAVA ENCRYPTION APPLET (process along with screenshot available at "[Bidders Manual Kit](#)") by accepting the risk and clicking on run.. If this application is not run then the bidder will not be able to save/submit his bid.
- 8.10 In all cases, bidders should use their own ID and Password along with Digital Signature at the time of submission of their bid.
- 8.11 During the entire E-tender cum Auction process, the bidders will remain completely anonymous to one another and also to everybody else.
- 8.12 The e-tender /Bidding floor shall remain open from the pre-announced date & time and for as much duration as mentioned.
- 8.13 All electronic bids submitted during the E-tender cum Auction process shall be legally binding on the bidder. Any bid will be considered as the valid bid offered by that bidder and acceptance of the same by the TANGEDCO will form a binding contract between TANGEDCO and the Bidder.
- 8.14 It is mandatory that all the bids are submitted with digital signature certificate otherwise the same will not be accepted by the system.
- 8.15 TANGEDCO reserves the right to cancel or reject or accept or withdraw or extend the tender cum auction in full or in part as the case may be without assigning any reason thereof.
- 8.16 The server time shall be treated as final and binding. Bids recorded in the server before the bid closing time will only be treated as valid bid. Bidders are,

therefore, advised to submit their bids well before the closing time of e-tender/auction. If any bid reaches the server after the bid closing time as per server time, the same will not be recorded and no complaint in this regard shall be entertained.

- 8.17 Bidders are advised to exercise caution in quoting their bids in e-tender/auction to avoid any mistake. Bids once submitted can't be recalled after bid closing time.
- 8.18 Any order resulting from this bidding process shall be governed by the terms and conditions mentioned in the NIT.
- 8.19 **Bidders are not required to sign in each page of the tender specification & upload. Instead bidders are required to fill up and sign the Tender Declaration Form given below & upload the same.**

## BID QUALIFICATION REQUIREMENTS

**THE BIDDERS shall become eligible to bid on satisfying the following BID QUALIFICATION REQUIREMENTS and required documentary evidences along with the tender.**

**The scanned copy of the following are to be uploaded.**

1. Earnest Money Deposit to be submitted on line. The bidders shall furnish 5% of the total rate quoted by them as EMD. If the 5% of the total rate quoted is less than Rs.500/-, **a minimum EMD of Rs.500/- per lot shall be furnished. EMD is to be remitted only through NEFT/RTGS mode before 02.00 PM on 14.06.2022 in the following account. TANGEDCO's account Name; Superintending Engineer / TEDC / TANGEDCO / Tuticorin, Collection Account No. 1124201002467 & IFSC Code CNRB 0001124 of Canara bank, Tuticorin payable at Tuticorin.**

**The scanned copy of proof for payment of EMD (i.e. e-payment receipt) duly reflecting the UTR Number shall be uploaded.**

2. The tenderer has to furnish the GST Registration in the tender. **The offers without the GST registration of the tenderer will not be accepted and it is liable for rejection.**

### **3. COLLECTION OF INCOME TAX AT SOURCE:**

The tenderer should furnish their Permanent Account Number (PAN) in their offer.

As per section 206'C' of the Income Tax Act, Income Tax collection at source is as follows:

- i) Income Tax Collection at source (TCS) in terms of section 206 'C' towards **sale of scrap is 1% .**
- ii) TCS sale if PAN furnished but Income Tax return not filed for FY 2019-20 & 2020-21 (w.e.f. 01.07.21) specified person u/s **206CCA - 5%.**
- iii) TCS rate if PAN not furnished and Income Tax return not filed for FY 2019-20 & 2020-21 (w.e.f. 01.07.21) (u/s-206CC (specified person) with **206CCA - 5%.**

## **Terms and Conditions of E-tender cum Auction.**

### **Instructions to Tenderer: -**

1. E- tenders are invited for and on behalf of Tamil Nadu Generation and Distribution Corporation Ltd., herein after referred as TANGEDCO for sale of certain items of scrap in "As is Where is Condition" as per this specification. All the tenders shall be prepared and uploaded strictly in accordance with the Instructions set forth herein.
2. The tender declaration form should be duly signed by the Tenderer himself. The Tenders without the signature of the Tenderer in the tender declaration form is liable for rejection.
  - a. If the Tenderer has any doubt about the meaning of any portion of this specification, he should seek clarification to the **Chief Engineer/ Distribution/ Tirunelveli Region ,TANGEDCO, Maharaja Nagar, Tirunelveli-11.** in writing, in order to have doubts cleared before the submission of the Tender.
  - b. In case, if the Tenderer feels that there is any ambiguity in any clause and conditions of the specification, the Tenderer should get it clarified from the Chief Engineer/ Distribution/ Tirunelveli Region/ Tirunelveli-11 before 48 hours of opening of the E-Tender.
  - c. In case, if the Tenderer feels that there is any ambiguity in any clause and condition of the specification and if the Tenderer fails to get it clarified before submitting his tender and wants any clarification, after submitting the tender / after opening of tender, the interpretation of such clause and conditions as made out by the Chief Engineer/Distribution/ Tirunelveli Region/ Tirunelveli-11 will be final and binding on the Tenderer. No withdrawal of Tender on this score will be permitted after opening of tender.
  - d. The Chief Engineer/Distribution/ Tirunelveli Region/ Tirunelveli-11 is the sole and final authority for deciding on any points of any clarification or disputes arising during the sale of the materials and such decision is not liable for any further reference to any authority.
  - e. Tenders shall be subject to all the condition stipulated in the Tender specification. Any other conditions of counter offers stipulated by the tenderers in their tender will not be accepted.
  - f. No suit or any proceedings in regard to any matter arising in respect of this contract shall be instituted in any court, save in the appropriate Civil court at Tuticorin or at the Court of small causes at Tuticorin . It is agreed that no other court shall have jurisdiction to entertain any suit or proceedings, even though, part of the cause of action might arise within their jurisdiction. In case, any part of cause of action might arise within the jurisdiction of any of the Courts in Tamil Nadu and rest within the jurisdiction of courts outside the

Tamil Nadu, then it is agreed to between the parties that such suits or proceedings shall be instituted in a Court within the State of Tamil Nadu and no other courts outside the State of Tamil Nadu shall have jurisdiction, even though any part of the cause of action might arise within the jurisdiction of such courts.

3. **Earnest Money Deposit: -**

- a. **The Tenderer shall furnish the EMD on line.**
- b. **The bidders shall furnish 5% of the total rate quoted by them as EMD. If the 5% of the total rate quoted is less than Rs.500/-, a minimum EMD of Rs.500/- shall be furnished.**

**Note:** During Tender creation in Government E- procurement portal, it is permitted to enter the EMD, only as a fixed value. Hence a minimum EMD of Rs.500 /- has been fixed.

- c. The Earnest Money Deposit paid by the tenderer will not carry any interest.
- d. The Earnest Money Deposits specified above should be submitted by means of NEFT / RTGS payable to the **Superintending Engineer / TEDC / TANGEDCO / Tuticorin, Collection Account No. 1124201002467 & IFSC Code CNRB 0001124 of Canara bank, Tuticorin payable at Tuticorin.**

**The scanned copy of proof for payment of EMD (i.e. e-payment receipt) duly reflecting the UTR Number shall be uploaded.** The EMD amount has to be received in TANGEDCO account through e- payment. The original proof shall be furnished within 1 week, on demand from TANGEDCO at a later date.

The details of proof for payment of EMD physically sent should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise, the uploaded bid will be summarily rejected.

In case of unsuccessful tenderers, the EMD will be refunded to them on application to the SE/ TEDC / Tuticorin **along with the details of Bank Account No. ,Name of the Bank and IFSC code of the bank** after intimation sent to them about rejection of their tender.

**Cheques /any other mode of payment will not be accepted towards EMD and the tenders shall be rejected if EMD is not paid in the prescribed manner.**

- e. **The offers of the bidders will be summarily rejected and their price bids will not be opened electronically, due to non compliance of EMD if:**

- i. the **scanned copy of RTGS UTR No. for EMD** is not uploaded online .
- ii. the tender is submitted **without sufficient EMD (ie.) 5% value of the quoted lots.**

**Special Note:**

- f. There will be no exemption to SSI and NSIC units from payment of EMD and therefore all tenders without the prescribed EMD will not be opened and will be summarily rejected.

**4. Submission of E-tender:**

4.1 The bidders shall submit their electronic-bids online as detailed below:

**4.1.1 Step-I: Entry of EMD Details**

**The bidders shall submit the EMD off-line.** However, during on line submission of bid, the EMD details such as DD No., date, Amount, Name of the Bank etc., shall have to be entered.

**4.1.2 Step-II: Uploading of Documents**

The documents shall be uploaded in 2 covers as detailed below:

i. **Cover-1 named "Fee/PreQual/Technical" :**

In this cover, the bidder shall upload the scanned copies of the following:

- a. Tender Declaration form duly filled & signed (Tenderer name, Full Postal address & contact details to be filled legibly without fail)
- b. The scanned copy of proof for payment of EMD (i.e. e-payment receipt) duly reflecting the UTR Number shall be uploaded.
- c. GST Registration Certificate & PAN Card
- d. Copy of Bank AC No. & IFSC code.
- e. Valid registration certificate with Tamil Nadu Pollution Control Board (TNPCB) / Ministry of Environment and Forest (MoEF), GoI, **if quoted for Battery Lot.**

ii. **Cover -2 named "Finance":**

In this cover, the rates for each lot shall be quoted. The bidder shall download the BOQ template available under "Work Item Documents" and fill up the name of the bidder & the rates offered for each lot in relevant column. After filling the details, the bidder should save it and upload without changing the file name.

**Note: The rates quoted shall be exclusive of GST. The applicable GST & other statutory levies, if any, for scrap shall be quoted separately. The same will have to be paid extra by successful tenderers.**

- 4.2 The bidder must fill up the EMD details and upload all necessary documents before making final submission. The Earnest Money Deposits specified above should be submission by means of NEFT / RTGS, payable to the

Superintending Engineer / TEDC / Tuticorin **Collection Account No. 1124201002467 & IFSC Code CNRB 0001124 of Canara bank, Tuticorin.**

- 4.3 **The scanned copy of proof for payment of EMD (i.e. e-payment receipt) duly reflecting the UTR Number shall be uploaded.** The EMD amount has to be received in TANGEDCO account through e- payment. The original proof shall be furnished within 1 week, on demand from TANGEDCO at a later date.

The details of proof for payment of EMD physically sent should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise, the uploaded bid will be summarily rejected.

In case of unsuccessful tenderers, the EMD will be refunded to them on application to the SE/ TEDC / Tuticorin **along with the details of Bank Account No. ,Name of the Bank and IFSC code of the bank** after intimation sent to them about rejection of their tender.

**Cheques /any other mode of payment will not be accepted towards EMD and the tenders shall be rejected if EMD is not paid in the prescribed manner.**

- 4.4 **The bidders shall upload the scanned copy of proof for payment of EMD (ie e-payment receipt) duly reflecting the UTR number.**

- 4.5 The Bids of only those bidders who have satisfied the EMD requirements shall be accepted.

- 4.6 The tender Declaration form should be submitted only in the prescribed form enclosed. The details of EMD paid by DD/Bankers Cheque/Pay Order should be furnished in the columns provided therefore.

- 4.7 The Tenderers are at liberty to quote for any lot, which they propose to purchase. Hence it is not compulsory that they should quote for all the lots given in the tender form abstract.

- 4.8 **For Battery and Dirty Oil Lot:** If the tenderer is proposed to quote for Batteries, then he shall be a registered recycler with Tamil Nadu Pollution Control Board/Ministry of Environment and forest Government of India. The tenderer shall enclose necessary proof for the same, otherwise their offer for battery lot will not be considered.

- 4.9 The Tender will be opened electronically at the Office of the Chief Engineer / Distribution/ Tirunelveli Region/ Tirunelveli-11 on the due date and time. In case, the due date for opening the Tenders happens to be a holiday, the tender will be opened on the immediate succeeding working day without change in the timings indicated.

## **5. Auction:**

- 5.1 The date & time period of Forward bidding will be intimated through the e-procurement portal / email after evaluation of the E-tenders.

- 5.2 The Highest (H1) price quoted in the e-tender will be fixed as the base price for the Auction. The bidding will be forward and the bidders shall quote higher rates.
- 5.3 The bidder shall participate in the Auction, only for the lots for which he has quoted in the e-tender. Bidding for the lots, not quoted by the bidder in e-tender, will not be opened for him. The bidders who have not participated in the e-tender cannot participate in the Auction also.

**5.4 Elimination of Bidder:**

**If minimum four bidders have quoted in the e-tender for a lot, then the lowest bidder quoted in the e-tender will be eliminated from participating in the auction process.**

**In the above case, if there are two lowest bidder quoted same rate in the e-tender, the bidder who have submitted their offer later in the e-procurement portal will be eliminated from participating in the auction process.**

**TANGEDCO has the right to allow any number of bidders to participate in Auction by eliminating the lowest bidders for each lot.**

**5.5 Bidding Parameters:**

The following parameters will be defined for the Auction:

- 5.5.1 **Bidding Start Time:** The Date & Time from which the Auction starts.
- 5.5.2 **Bidding End Time:** The Date & Time at which the Auction ends.
- 5.5.3 **Increment value:** The bidder shall increase the price only in multiples of the stipulated increment value .
- 5.5.4 **Increment % :** The bidder shall increase the value only upto the increment %

**Example 1: If Increment value : Rs. 100/- , Increment % : 50 % & H1 rate: Rs.600/-**

**1<sup>st</sup> Bid :** The maximum rate that can be quoted is Rs.900/- (600 +300 (50% of Rs.600)). Hence the bidder shall quote Rs. 700, 800 (or) 900. Assume the 1<sup>st</sup> bid value is Rs.900/-

**2<sup>nd</sup> Bid :** The maximum rate that can be quoted next is Rs.1300/- (900 +450 (50% of Rs.900)). Rs. 1350/- will not be accepted as the increment value is Rs.100/-. Hence the bidder shall quote Rs. 1000, 1100, 1200 (or) 1300.

- 5.5.5 **EIapse Time:** The time within which if a bid is submitted, the bidding end time will be automatically extended.

5.5.6 **Auto Extension Time:** The time upto which the Auction time will be extended, if a bid is submitted within the 'Elapse Time'.

**Example2: If Bidding End Time: 2 P.M, Elapse Time : 5 Min & Auto Extension Time : 10 Min**

**If a bidder submits his bid during the last 5 Min (Elapse Time) ie., 1.55-2.00 P.M , the bidding end time will be automatically extended upto 2.10 P.M. If no bid is submitted during the Elapse Time, the Auction floor will be closed.**

- 6.1 In the case of unsuccessful Tenderers, the Earnest Money Deposit will be refunded to them on receipt of application together with one stamped advance receipt in duplicate for the EMD paid by them to the **Superintending Engineer / TEDC / TANGEDCO / Tuticorin**, after intimation is sent to them.
- 6.2 The Earnest Money Deposit paid by successful Tenderer will be adjusted in the sale process of such successful Tenderers.
- 6.3 The tenderer has to furnish the GST Registration in the tender. **The offers without the GST registration of the tenderer will not be accepted and it is liable for rejection.**
7. The TANGEDCO reserves the right:
  - a. To accept the highest (or) any eligible Tender.
  - b. To reject any or all the Tenders without assigning any reasons thereof whatsoever.
  - c. To revise or retain the quantities of any or all the items covered by this specification at any time and release the balance for sale even when the successful Tenderer are clearing the materials. Under such circumstances, the cost of materials collected in excess will be refunded to the successful Tenderer without interest.
  - d. To reduce the quantities to be sold, if necessary, during the pendency of the Tender.
8. After freezing the Auction, the highest offer is identified for issue of sale orders, if the rates are acceptable and approved by the competent authority.
9. **The successful tenderer shall pay the EMD for 5% of the price (H1) quoted in Auction after deducting the EMD already paid for the respective lots, within 7 days from the date of intimation for issue of sale order. If the difference in EMD is not paid within the stipulated time or the successful Tenderer backs out, EMD amount already paid will be forfeited without further reference to him. The backed out tenderer shall also pay the difference in EMD to TANGEDCO failing which he will be banned from participating in future tenders. No plea for non-remittance of the difference in EMD in time will be entertained.**



10. The sale orders will be issued to the successful tenderer on receipt of the difference in EMD within the stipulated time and the successful Tenderers are requested to remit the sale amount to the respective circles on receipt of sale confirmation order.
11. The time limit for payment shall be 21 days from the date of receipt of sale order and materials shall be lifted within 15 days from the date of receipt of release order.
12. Delayed payment of sale value will not be accepted. For delayed payment, interest at **22% per annum** shall be collected, if approved by competent authority. If the materials are not lifted fully, ground rent at the rate of Rs.100/- Per Lot / per M.T. or part thereof per day will be levied upto a maximum period of 15 days from the expiry date of lifting the materials.
- 13. INSPECTION:**
  - a. The materials can be inspected by those who are interested in the **purchase as per the terms and conditions of this specification on any** working day, during working hours. The Officers, who are in charge of the premises where the materials offered for sale are available, will permit such inspection.
  - b. The inspection of the materials will be permitted only on production of specification copy to the Officer in charge of the Stores in the working days ( 8AM to 5.15PM).
  - c. The Successful tenderers will not be permitted to bring dealers or merchants for inspection of materials for further examination of materials in the Stores/ premises, once the Tenders are finalized.

#### **14. COLLECTION OF INCOME TAX AT SOURCE:**

The tenderer should furnish their Permanent Account Number (PAN) in their offer. As per section 206'C' of the Income Tax Act, Income Tax collection at source is as follows:

- i) Income Tax Collection at source (TCS) in terms of section 206 'C' towards **sale of scrap is 1%** .
- ii) TCS sale if PAN furnished but Income Tax return not filed for FY 2019-20 & 2020-21 (w.e.f. 01.07.21) specified pension u/s **206CCA - 5%**.
- iii) TCS rate if PAN not furnished and Income Tax return not filed for FY 2019-20 & 2020-21 (w.e.f. 01.07.21) (u/s-206CC (specified person) with **206CCA - 5%**.

In case of sale of scrap by TANGEDCO, a declaration has to be obtained from the buyer as to whether 194Q is applicable to them. In case if section 194Q is declared as applicable to the buyer, then TANGEDCO should not collect TCS under section 206C91H). However, when the buyer fails to deduct TDS under section 194Q, then

TANGEDCO is liable to collect TCS under section 206C(1H). The formats of declaration for deduction of Tax at source under 194Q and declaration pursuant to section 206AB are to be provided to the lifters of scrap are enclosed as annexure B.

It is informed that as TANGEDCO has a valid PAN and filed the Income Tax returns for last two financial years, hence higher rate of TDS specified in section 206AA and section 206AB of Income Tax will not apply.

M/S. Tamil Nadu Generation and Distribution Corporation Limited have filed the Return of Income (ROI) under the relevant provision of the Income Tax Act, 1961 for the Assessment year 2019-20 and 2020-21 (FY 2018-19 & FY 2019-20) and shall file the ROI for Assessment year 2021-22 (Financial year 2020-21) within the due date as per the provisions of the said Act. The permanent Account No. (PAN) of TANGEDCO is AADCT4784E.

Therefore, higher rate of TDS u/s. 206AA & u/s. 206AB will not apply to TANGEDCO.

#### 15. PAYMENTS AND DELIVERY: -

- a) The successful Bidders should remit the entire amount to the **Superintending Engineer / TEDC / TANGEDCO / Tuticorin** within 21 days from the date of receipt of sale order from the Chief Engineer / Distribution / Tirunelveli Region by demand draft / Banker Cheque / Pay order / RTGS **(for RTGS to the Superintending Engineer / TEDC / TANGEDCO/ Tuticorin Collection Account No. 1124201002467 of Canara bank, Tuticorin & IFSC Code CNRB 0001124) payable at Tuticorin** and produce the cash receipt to the Stores Officer/ **TEDC / TANGEDCO / Tuticorin. The Superintending Engineer / TEDC / TANGEDCO/ Tuticorin** will issue the release order. The release order will be issued only on receipt of the entire amount.
- b) The sale order and release order will be issued to the successful Tenderer who has submitted the quotation. No change in name or address or transfer of sale or release order will be permitted.

If the sale order is returned due to non-availability of the address or vague address, the TANGEDCO will not be held responsible. It will be assumed that the Tenderer has backed out and is uninterested in the purchase of the items

covered by this specification. Hence the Tenderers are requested to ensure proper and correct postal address in the envelope.

- c) If the entire amount is not paid by the successful Tenderer within time stipulated above or the successful Tenderer backs out, EMD amount will be forfeited without further reference to him. No plea for non-remittance of the amount in time will be entertained and partial remittance is also not permitted.
- d) The purchased materials should be removed completely by the successful Tenderer from the TANGEDCO's premises within 15 days from the date of receipt of release order and the TANGEDCO will not afterwards be responsible for any loss or damage to the materials not taken over.
- e) In case, the successful tenderers fail to remove the purchased materials within time limit specified above, either partly or fully, ground rent at the rate of Rs.100/- (Rupees hundred only) per MT/Lot or part thereof per day will be levied for the unlisted quantity upto a maximum period of 15 days from the expiry date for lifting the materials and collected.
- f) If the successful bidder fails to remove the purchased materials completely or partly from the TANGEDCO's Stores within 30 days from the date of receipt of release order, they will not be allowed to remove the purchased materials thereafter and the amount paid to remove the purchased materials and the EMD paid by them will be forfeited by the TANGEDCO without further reference to them. Plea for non-clearing the purchased materials in time and request for further extension of time for lifting the materials will not be entertained. The successful Tenderer will have no claim for compensation whatsoever.
- g) The materials are for sale and delivery from TANGEDCO's premises under "As Is Where Is Condition". Selection or segregation of materials will not be permitted. The successful Tenderer should make his own arrangements for providing labour at his expenses for weighing, packing etc., of the materials.
- h) If the quantity is less than the quantity offered for sale, the proportionate cost will be refunded without interest to the successful Tenderer after the release is completed.
- i) The materials will be handed over only to the successful Tenderer or to his accredited representative duly authorised and whose signature is attested by him.
- j) Removal of the materials should not in any way interfere with TANGEDCO's works that may be in progress there. The purchasers employee engaged in the removal of materials shall work subject to the TANGEDCO's rules and discipline.

- k) The TANGEDCO will not be responsible for any damage or loss that may be suffered by the successful Tenderer or his representatives in the course of removal and transport of the materials.
- l) Successful Tenderer is responsible for all acts of his employees and any damages to the properties of the TANGEDCO or any person or public body in the course of movement of his vehicles and transport of the materials shall be made good by him. In case of accident to any staff of TANGEDCO in the course of removal and transport of materials, the successful Tenderer shall pay necessary compensation that may be awarded to the person or persons involved in the accident according to workmen's compensation act besides arranging immediate medical aid.
- m) The weight of the materials as determined in the TANGEDCO's weighing scales is final. Bidders are advised to satisfy themselves regarding the quality and condition of the materials before tendering. The TANGEDCO is not responsible for any deterioration or loss in the materials from the date of tendering to the date of removal from the site and no representation about the quality and conditions of the materials during the above period or at the time of taking delivery or at any time thereafter will be entertained on any account.
- n) The materials which are accounted on weight basis shall be weighed in the presence of one or two TANGEDCO Officers in the departmental weighing machine or lorry weigh bridge available at the stores and the weights recorded by the weighing machine of the TANGEDCO will be final and shall be accepted by the successful Tenderer. The weighing machines are periodically maintained and certified by the competent authorities.
- o) The successful Tenderer shall remove the weighed quantity then and there, under separate Gate pass for each consignment sent out through his vehicles and then only take up further weighment. No part of the weighed quantity will be allowed to be kept in the departmental premises after the weighment are done.
- p) The materials removed from the stores should not be dumped outside the stores.
- q) The materials will be released only during the working day or working hours of the stores. The successful Tenderer should remove the materials from the stores premises within the working hours of the stores. The successful Tenderer should also contact the Officer in-charge of stores in advance about the availability of the Officers and arrange for vehicle and men for taking delivery of materials.
- r) The materials will be released only on production of the release order at Stores.

- s) Any loss sustained to the TANGEDCO on account of re-sale of materials due to backing out of the successful Tenderer (defaulter), the difference between the original sale value and the re-sale value will be recovered from the defaulting Tenderer of the first sale.

#### **16. VALIDITY:**

- a) The rate offered should be valid for 120 days from the date of opening of tender. If the approval of the offer is delayed due to any unforeseen reasons/ circumstances, the rates quoted should be valid for a further period of 60 days (i.e.) in total the rates should be valid for **180 days**.
- b) No Tenderer will be allowed to withdraw the offer within the validity of 180 days specified. If the Tender is withdrawn by the Tenderer before the expiry of the validity period, the EMD paid will be forfeited. The Tenderer cannot quote his own validity period and such tender will not be considered and will be rejected.
- c) The sale will be from TANGEDCO stores in "As is Where is Condition" basis.
- d) **Appropriate rate of GST as per the provisions of rules & other statutory levies, if any, for scrap will be levied and the same will have to be paid extra by successful Tenderer.**
- e) If any revision in the rate of GST is ordered by the Government at the time of payment of sale value, the rates prevailing then will be levied and collected from the successful Tenderer.

#### **17. TENDER REGULATION TO APPLY:**

The Tamil Nadu Electricity Board Tender Regulations 1978 with latest modification "Mutatis Mutandis" shall apply to this Tender also.

The TANGEDCO is the competent authority and shall have the right to relax or waive any of the conditions stipulated in this specification. The Competent authority reserves the rights to decide the Tender.
