11. The Executive Engineer, WRD, Parambikulam Division, Parambikulam will be authority for executing the agreement.
12. The Contractors may have option either to present the Tender directly or to send it by Registered Post Acknowledgement Due. It is the responsibility of the tenderer himself to despatch the tender sufficiently early so as to reach the tender opening authority before the date notified in the tender notice for receipt of tenders. No representation or appeal of any kind will be allowed against belated receipt of tenders by post beyond the notified date or loss in transit etc., The decision of the Executive Engineer in this regard is final.

14. The G.S.T. clearance certificate issued by the commercial taxes department of this state will also be produced before final settlement of the bills.

E.M.D. shall be accepted in the form of National Savings Certificates / Small Savings / Deposit Accounts duly pledged in favour of the Executive Engineer, WRD, Parambikulam Division, Parambikulam. In case of E.M.D. is produced in the form of Demand Draft issued by the Nationalised Bank the successful tenders will have to replace the E.M.D., into the acceptable forms before the execution of agreement. The tenders submitted without the EMD., will be summarily rejected.
