**Single cover system shall be adopted for the above work.** The tender document shall be filled with relevant details duly signed and the completed tender document along with required certificates **duly attested by a gazetted officer/Notary public** shall be submitted in a sealed cover and superscribed properly along with the Name of work and addressed to the **Superintending Engineer, SIPCOT, Chennai-8** and dropped in the tender box available in SIPCOT Head Office, Egmore, Chennai-8 on the due date in person either by the tenderer or by their representatives. Tenders received by post or courier service could not be taken up for consideration. Tender received without EMD and belated tenders are liable for rejection without any intimation. EMD is liable for forfeiture if the tenderer withdraws his tender after acceptance of tender or if he does not pay the S.D. within specified time.
