The **Technical cum Commercial Bid** will be scrutinized first and those who qualify in the **Technical cum Commercial Bids** satisfying all the tender conditions will only be considered for Price Bid stage.

QUALIFYING CRITERIA:-

Please note that the following points asked for in the TECHNICAL CUM COMMERCIAL BID are the qualifying factors in the Tender. Therefore, <u>Tenderers who do not comply with the conditions with documentary proof (wherever required)</u> will not be qualified in the Tender for price bid stage.

- Tenderer should be a manufacturer (Registration Certificate/GST should be enclosed as proof along with the technical bid without fail). In case of Dealer/ Importer, Authorisation Letter in Original from the manufacturer and copy of Registration Certificate/GST certificate of the Manufacturer are to be submitted along with technical bid without fail.
- 2. Submission of non refundable tender fee for Rs.590/- .
- 3. Submission of earnest money deposit.
- **4.** Submission of sample and its acceptance at our lab.

- **6.** Tenderer should provide documentary evidence for having supplied the proposed pigment dyes <u>in the last three years</u> to a **fine paper mill operating at a speed not less than 650 meters per minute.**

- **7.** Acceptance of terms of payment as per tender terms.
- **8.** Submission of tender within due date and time.
- **9.** Acceptance for the following clause on trial period.

"The successful bidder (supplier) in case happens to be a new supplier, will be under probation for one month period in order to establish performance. If the supplier's performance is poor, the order will be cancelled and the supplier will be banned for 2 years".

10. The Tenderer should consider the minimum consumption norms given in the Technical details. The offers received with consumption norms below the minimum consumption norms will not be considered.

PRICE BID STAGE:

At Price Bid stage, TNPL will follow the following methodology to finalise the tender:-

- 1. Price Bid will be obtained from the tenderer in a separate sealed cover along with technical cum commercial bid.
- 2. TNPL will fix the opening price and minimum bid decrement for the E-auction (Reverse Auction). The date and time of E-auction will be communicated to the technically qualified tenderers separately.
- 3. After completion of the Reverse Auction bidding, on the same working day at 4.00 PM, TNPL will open the Price Bids of the qualified tenderers in the presence of interested bidders.
- 4. The lowest offer received through E_auction or through Price Bid whichever is lower will only be considered for placement of order.

The above production break up is tentative and may change as per Market requirements. In Copy crown Violet Dye consumption will be minimum to a tune of 60-80 gms./MT and blue dye consumption will be on higher side to a tune of 200-220 gms./MT. Vendor must note this condition.

Final Paper Shade of different grades in each machine target L, a, b values are different. Vendor must take care of this and submit their offer accordingly.

Fillers Used

- > Wet Ground calcium Carbonate and Wet Precipitated calcium Carbonate.
- Presently, we are using WPCC&WGCC in 1:1 combination. Mill may use 100% WPCC/WGCC (or) in any combination of this filler in all varieties during the period of the contract.
- ▶ WPCC and WGCC will be supplied by Onsite M/s. OMYA slurry form with suitable dispersing agent.
- ▶ WGCC will be at 50% solids and WPCC will be at 20% solids. This proportion of solids may vary as per production conditions.
- > Occasionally, powder GCC/PCC will be used as per requirement.

<u>Note</u>: During the monsoon and summer, the turbidity level of river water may change, which may result in reduced water quality and drop in brightness of the incoming pulp to a degree of 3-4% ISO.

The tendency of variation in pulp brightness is on lower side and variation in yellowness of the pulp is on higher side during these seasons. - The shelf life of Pigment Dyes shall be specified by the vendor and marked legibly on each carboy for acceptance.
- The pigment dyes should be homogenous, and should not settle down on storage.
- The pigment dyes should not be filled in polythene bags. It should be directly filled in to the carboys and lid should be air tight to avoid spillage.
- The supplier should maintain distinct colors for the carboys / labels for the violet and blue pigments for easy and clear identification.
- Vendor to quote the consumption norms for the machine production above the minimum quantity stated above taking in to consideration of all the above pulp parameters like Brightness, Yellowness, Water Quality, Retention condition, Back water system conditions and other parameter variations in machine etc.
- No consideration/claim of excess quantity of the dye consumption over the agreed norms is entertained strictly at any circumstances. Vendor must make a note of this condition clearly before quoting these consumption norms.
- The material receipt date in TNPL shall correspond to not less than 50% of the shelf life remaining for the chemical.
- The Pigment dyes shall not have adverse impact on environment.
- The vendor shall maintain inventory at a level not exceeding one month requirement at TNPL Stores.
- The vendor should submit copy of Product Data Sheet and Material Safety Data Sheet (MSDS) along with the Technical-cum-Commercial Bid without fail.
- The vendor to station experienced representative at TNPL site for monitoring of Consumption & Inventory on daily basis.
- The Pigment dyes should not have any suspended material & it should not develop deposition problem in storage & delivery lines.
- The vendor shall maintain qualified and trained representative for continuous monitoring of addition and inventory of pigment dyes.
- The pigment dyes offered should have FDA or equivalent agent approval.
- The registration number of the FDA or equivalent may be provided with the technical-cumcommercial bid.
- Vender to monitor the condition of dye addition in the system. Addition of dyes should not
 affect the quality of paper made due to dye spots problem during quality change and during
 normal run.
- Vendor should ensure the quality of the dyes and must ensure that it shall not produce dye spots in the paper (or) affecting shade of the paper.
- Vendor should provide proper cleaning method of dye preparation and dosage system to avoid dye spots problem.
- Vendor must ensure proper addition of biocide for the dye to avoid any microbial growth during the course of usage.
- Vendor should submit the Standard Operational Procedure for handling the pigment dyes at TNPL end
- The pigment dyes should not contain dye fragments which may cause dye spots in paper. If present inadvertently, it is the responsibility of the supplier to filter the same at their own responsibility and should provide fragment free dyes.
- If sediments are present in the supplied dye even after repeated instructions, the lot of pigment dye shall be totally rejected at our end in joint inspection by lab and production. Suitable compensation shall be recovered from vendor for any rejection due to dye spots on the final paper.
- Vendor should note that approximately around 2000 MT/ Month (Tentative) of Natural shade variety in all three machines will be manufactured. This production quantity will not be considered in the consumption report for payment as dyes will not be used in Natural shade variety.

01. QUALITY:

Quality is the essence of this tender. The supplier shall supply the material strictly as per the specification mentioned above. The material supplied will be inspected at our factory. Quantity as ascertained on receipt of material at our Site will be treated as quantity supplied wherever the package is received intact. As regards quality, our laboratory test report will be final and our decision on acceptance or rejection will be final and binding on you.

02. RATE:

- Tenderer should quote their rate as a single Package cost /tonne of machine production for both the chemicals namely PIGMENT VIOLET DYE AND PIGMENT BLUE DYE during Reverse Auction considering the tentative six months production of 2,40,000MT of Paper for all 3 Machines put together.
- To arrive at L1 Position, TNPL shall follow single Package Cost per tonne of Machine Production on Landed Cost (Net of GST) for all 3 Machines put together for both Reverse Auction and in the Price Bid.
- The successful vendor should provide immediately after the Reverse Auction bidding, unit cost of each chemical i.e. Basic price, Freight, GST etc and also to indicate the consumption of each chemical per tonne of machine production for PM 1, 2 & 3. Quantity of chemicals required (rounded off) based on the estimated production given in the tender is to be provided immediately after the bidding is over.
- The rate should be offered on F.O.R.Kagithapuram basis with detailed price breakup by the tenderers for despatch. The chemicals are to be supplied in good quality non-returnable 50 kgs Litres IBC returnable containers.
- Vendor to quote dye consumption norms combined for all three machines.

03. VALIDITY:

The rate quoted during on line auction should be kept valid for a minimum period of **90 days** from the date of Reverse auction held / opening of Price Bid. During the validity period, bidder is not permitted to make any upward revision in the rate. The order shall be kept valid till completion of order quantity or till completion of validity period of **six months** whichever is earlier. During the validity period of the order as above, no upward revision in price will be allowed except in case of increase in statutory levies.

04. TAXES:

Goods and Service Taxes (GST) if applicable should be mentioned clearly and separately with the percentage of taxes applicable. GST invoice should be sent along with each supply for the purpose of availing input tax credit (GST). Copy of GST invoice should be sent in a separate cover addressed to **AGM (Stores)** as may be specified in the purchase order. Without copy of GST invoice, material will not be unloaded.

Please note that, as TNPL shall avail input credit (GST), please mention clearly in the offer the applicable taxes. TNPL shall take the same into consideration while evaluating the offers. GST will be paid to the supplier, only if the input Tax Invoices / Debit Notes has been reported in GSTR-1 and corresponding GSTR-3B is filed.

05. TRANSPORTATION:

- a. It is the responsibility of the supplier to arrange transportation and supply the material on F.O.R Kagithapuram basis. TNPL requires the material on F.O.R. Kagithapuram basis only.
- b. The actual weight recorded in TNPL Weigh Bridge will be taken for accounting and payment purpose. Hence, TNPL weight is final.

- a) "100% payment will be released on the basis of Agreed Package Cost per tonne of combined Machine Production (Net of GST) for PM 1, 2 & 3 after successful and satisfactory completion of one month operation duly certified by our User Department. While making payment, Package Cost per tonne of combined machine production (Net of GST credit) based on the actual consumption of individual chemicals will be arrived. It will be compared with the Agreed package cost per tonne of Machine Production (Net of GST credit) and whichever is lower will be paid. When the actual package cost (based on actual consumption of individual chemicals) is higher than the Agreed Package cost, for the excess consumption of individual chemicals, statutory levies only will be paid as claimed in the invoice and the other costs like material cost, freight, insurance etc. will not be considered". Please note that for making payment, actual consumption of both chemicals and agreed norms would be considered for all the three machines put together.
- **b)** Payment will be released within 7 days from the date of User certification.
- **c)** We are now sending payment to the customers through RTGS Scheme through our Bankers M/s.Indian Overseas Bank, Kandampalayam Branch, Velayuthampalayam, Karur District and M/s.State Bank of India, Pugalur Branch, Kagithapuram.
- **d)** RTGS payment will be made within 7 days from the date of certification.

Note: Since the tender Production quantity of 240000MT is for six months, six months average on the consumption will be considered for making payment.
