TENDER NOTICE

Sealed tenders in the prescribed form on schedule basis are invited for and on behalf of Arasu Rubber Corporation Limited, Nagercoil for the following items, up to 3.00 P.M. on 25-07-22.

“Supply of once used, Light Weight reconditioned empty barrels from 01-08-2022 to 31-03-2023”.

Tenders received will be opened on 25 -07-2022 at 3.30 P.M by the Managing Director or an Officer authorized by the Managing Director or otherwise postponed by publication in the Notice Board. If the date of tender happens to be holiday, the tender shall be received and opened on the next working day, at the appointed time and place. There will be a negotiation immediately after opening the tender. Earnest Money Deposit in the form of Demand Draft obtained in favor of Arasu Rubber Corporation Limited, Nagercoil shall be submitted along with the tender. Tender received after 3.30 P.M on 25-07-2022 will not be considered. The Earnest Money Deposit of the successful tenderer will be retained as Security Deposit and refunded only after completion of satisfactory supply. The EMD of unsuccessful tenderers will be refunded after finalizing the tender. Tender schedule can be obtained from this office on any working day from 01-07-2022 to 24-07-2022 during Office hours and on 25-07-2022 up to 1.00 P.M. on payment of the cost of tender schedule noted against each lot by cash or demand draft/pay order on any Nationalized Bank in favor of Arasu Rubber Corporation payable at Nagercoil. Tender schedule can also be downloaded from our Website www.arasurubber.tn.gov.in and payment receipt (cash/DD) for the tender schedule must be attached with Tender documents.

CONDITIONS

1. **Rate per Unit:** The rate quoted in the tender should be for per number (mentioned in the Tender schedule) for the supply of materials covered in this tender notice.
2. **Delivery Location:** The rate quoted in the tender should be inclusive of loading, unloading and transporting and any other incidental charges for delivery at site, i.e., Store shed of Rubber Factory, Keeriparai.

3. **GST:** The rate quoted should be excluding GST and the GST should be mentioned separately in the bill. The certificate copy of GST Registration number and PAN number for income Tax should be furnished while applying for tender schedule.
4. **Tender Cover:** On the top of tender cover, the name(s) of supply of materials should be superscribed.
5. **Sample and Quality of Material:** The tenderer should see the sample of the materials available at Keeriparai Rubber Factory Arasu Rubber Corporation and quote the rate. The tender rate and the supply should be as per the sample. The materials should be supplied as per specifications. For supply (or part supply) of defective materials or for materials not as per the sample, the supplier will be liable for action as deem fit by the Managing Director, Arasu Rubber Corporation, Nagercoil.
6. **Tenders liable for summary rejection:** If the present supplier is noticed as "defaulter" during the present contract period, the tender offered by him/her in this tender will not be considered. Also, conditional tenders regarding the rate, etc. will not be taken into consideration. Tenders without EMD will not be considered.
7. **EMD and Security Deposit:** EMD of the successful tenderer will be retained as interest free Security Deposit.
8. **Delivery Schedule:** The supplier should supply the materials as per the delivery schedule to be drawn by the Managing Director, Arasu Rubber Corporation Limited or any other officer authorized by Managing Director and communicated from time to time. The supply of the materials should be commenced soon after the receipt of confirmation orders and completed before the period mentioned in the Annexure. After getting supply orders, the tenderer should not deny to supply the materials. If supply is delayed or negated, action will be taken, to recover the loss sustained by Arasu Rubber Corporation and other requisite action, as deemed fit by Managing Director. In case of failure to complete the supply of materials at the agreed rate and within the prescribed time as per schedule of supply, the Managing Director at his discretion can cancel the order for the undelivered quantity and call for fresh tenders for the undelivered quantity or make any other arrangement to get the materials supplied at the risk and responsibility of the original supplier who is liable to make good the loss to Arasu Rubber Corporation that may arise due to such default on the part of the supplier. In case tenders are called for afresh at the risk of the defaulting suppliers, the defaulter supplier will not be allowed to send the tender and the name of the defaulting supplier will be removed from list of suppliers being maintained in this Office.

9. **Delivery Acknowledgement:** Intimation about the date of delivery of materials should be sent in writing to this Office sufficiently in advance, along with a copy marked to the Factory Manager, Rubber Factory, Keeriparai. The materials supplied should be delivered at the mentioned Delivery Point and necessary acknowledgement must be obtained from an Officer of the Rubber Factory not below the rank of Factory Manager.
10. **Rejected Materials:** Rejected materials should be removed at the expenses of the contractor within 7 days after notice. If not so removed, the Factory Manager, Rubber Factory, Keeriparai may cause the materials to be removed and charge the supplier with all expenses incurred. In addition, demurrage shall have to be paid by the contractor at the rate of Rs.1/day/barrel.
11. **Penalty:** If the materials or part of materials supplied are found to be defective or not as per the sample and specifications, the Managing Director will take action as deemed fit. Also, in case of failure to complete the supply of materials at the rates fixed or not supplied as per the delivery schedule or within the time specified, the EMD deposited by the supplier will be liable to be forfeited in part/full (as deemed fit) to Arasu Rubber Corporation Limited and the Managing Director, Arasu Rubber Corporation Limited reserves to himself the right to cancel the order for the undelivered quantity. The defaulter will not be allowed to participate in future tenders for periods fixed by the Corporation.
12. **Bills:** The bills for the supply materials delivered at the delivery site should be prepared in duplicate and sent to the Factory Manager, Rubber Factory, Keeriparai along with necessary certificates.
13. **Payment Schedule:** 80% payment on receipt of acknowledgement from the Factory Manager, Rubber Factory, Keeriparai and balance 20% payment after quality check and certificate from authorized Officer.
14. **Agreement:** The successful tenderer whose tender is accepted for the supply of materials covered under this tender should execute an agreement on the stamp paper worth Rs.50/- in the form prescribed for the due fulfillment of the contract with Managing Director, Arasu Rubber Corporation, along with Security Deposit as fixed by Managing Director at the time of the execution of agreement. Failure to execute the agreement within the time as specified will result in the forfeiture of the EMD (in part/full, as deemed fit) besides action for any other loss sustained by the Corporation, as deemed fit by the Managing Director.
15. **Refund of EMD/SD:** Upon fulfillment of the contract by the supplier to the satisfaction of the Arasu Rubber Corporation Limited, the sum deposited as Earnest Money Deposit/Security Deposit by the supplier shall be returned to him/her after deducting all dues and penalty (if any). No interest will be paid on the EMD/SD.

16. **Quantity:** The quantity noted in the schedule to this notice is only approximate and the actual quantity may be more or a little less than the specified quantity. Managing Director, Arasu Rubber Corporation reserves the right to order the quantity as per requirement of the Corporation.
17. **Small Scale Industries:** Small Scale Industrial units sponsored by the TANSI/SIDCO, Khadi and Village Industries Board or any such organization, they should produce the EMD as noted in the Tender Schedule. They should obtain the Tender Schedule with cost. Since all the existing Regulations, Department Codes and Manuals, Orders shall so far as they are not in consistent with the provisions of Tamil Nadu Transparency in tenders Act, 1998 and the rules there under continue in force.
18. **Dispute, Arbitration and Appeal:** All claims and disputes arising under or relating to this agreement are to be settled by binding arbitration between the parties at Nagercoil by the mutually agreeable arbitrator. In case of failure of arbitration, any dispute arising in respect of the contract on the orders of the Managing Director (other than those for which the orders of the Managing Director, Arasu Rubber Corporation Limited, Nagercoil have been declared to be final), may be appealed by the supplier to the Board of Arasu Rubber Corporation Limited, within 3 months from the date of the order of the Managing Director, Arasu Rubber Corporation Limited, Nagercoil and the decision of the Board shall be final and conclusive.
19. **Jurisdiction:** For any dispute arising out of this contract, the Court in Nagercoil alone will have the jurisdiction.


