## 2. SPECIAL CONDITION FOR REVENUE RECOVERY

## **SPECIAL CONDITION FOR CEMENT & STEEL DEPORTMENT SUPPLY**

1. Cement and Steel will be suplied by the Deportment at Deportment store at Consernend Panchayat Union section store at the cost specified below and the same will be recoverd from the contracter's bill

(A) Cement: 5960/ MT

(B) Steel(RTS&MS): 51750/MT

2. The contracters rate for the respective items involving cement and steel should including cost and conveyance from deportmentel stores to worksite and proper handling charges at both ends.

3. The contractors rate shall be inclusive of all Sales Tax if any which he has to pay to Government.

4. The contracter should make his own arrengements to take delivery of the materials at the deportmental stores worksite during office hours on all working days. The contractor should make necessary arrangements to protect the deportmental measure the cost of damged materials shall be made good from the contractor.

5. Cement & Steel required for the above work will be supplied in sufficient quantity as and when required in consistant with the progress of works as decieded by the Deportmental Officers. The contractor shall arrange to store the materials sufficiently in large quantities to ensure continutly of the work He shall also be responsible for the proper storage preservation of the materials in good condition.

For the quantity of cement & steel cost wasted or used in exess of the prescribed quantites by more then 5% for cement and 2.1/2% for steel non-returend by the contactor the recovery cost will be double the issue rate plus storage or market rate whichever is higher. The decision of the contractor / chairman, District Rural Development Agency should be final for constitutes the quantity cement lost wasted or used in excess of the prescribed requirement and shall be binding on the contractor

Any varrition in the cost of materials procured by the contractor will be to their account. The contractor will not be eligible for any extra amount on this account at any time

6.Empty gunny bag need not be retuned to the deportment . They will become the property of the contractor

7. All testing charges cost of cubes , labour transport and incidental charges will be to the account of the contractors.

8. The Deportment will not undertke supply of water if it for plain pre-stressed RCC Works . It is the responsibilities of the contractor to get from approved source Water shell conform the specification 108-12-212 and 1007.02 of SSRS . The rates quated shall be inclusive of charges for procuring and transport of water to site whatever be the distance.
